



## REPORT OF THE PRESIDENT B/A KEITH D. HILL AUGUST 2019

Below is my report for the month of August 2019, presented to the Executive Board on August 28, 2019 and the Members on September 3, 2019 during the Mass Membership Meeting.

### **CTA CONTRACT CAMPAIGN:**

- The time has come for us to start preparing for our next round of negotiations with the CTA. As this administration prepares, we will be scheduling meetings with multiple departments to hear all concerns and ideas on how to better advance you in your job.
- Also, be on the lookout for the proposal sheets to be on the property soon. The proposal sheet will be different, to reflect the department you work in order to address your department needs and concerns.
- Notices for meetings will be on the property as well with multiple days to try to reach everyone to voice their concerns and wishes as we begin this campaign.
- The Union is planning to start negotiations sixty days before the expiration of our current agreement. There will be multiple days scheduled in October for you to voice your concerns and ideas.
- This administration looks forward to hearing from all members no matter what department you work in, so let's get ready and produce another contract with no loses or givebacks.

### **ATU INTERNATIONAL CONVENTION:**

Local 241 will have a bylaw change on the floor at the International Convention. After surviving two trusteeships and seeing the autonomy that the International has to change bylaws when a local is placed in trusteeship, is not a total bad thing. After talking with Sister Toi Bowers, we decided to present one from Local 241. After the last trusteeship the International changed our bylaws that I think, some of the changes were good and some of the changes handicapped the Local.

#### ATU INTERNATIONAL CONVENTION (cont.):

- An IVP (International Vice-President) who is not a member from the Local or is not familiar with the structure that surrounds that Local, should seek the help of the membership, because members in that Local are the ones who must live with the structure in place.
- To sum it up short, we are requesting that before the International make changes, they must get a committee of members that can weigh input to keep the Local structure in place. Also, we will be pushing the resolution from our "Maintenance Department". This will mirror somewhat of what the Teamsters' Local does for its members to make sure their craft is protected. This will also help our "Maintenance Department", I think in many different areas when we get back home and start our contract fight.
- I also would like to lobby other Locals to prepare for the next convention. After talking with several Locals, I wanted to push that we freeze the yearly "Per Capita" increases and limit it to a vote at the convention. This idea does not gain much support among other Locals, so I hope we start working for the next convention to get this passed.
- So, I look forward to all Local 241 Delegates working the room and pushing the two items we have on the floor.

### **CHANGING OF SEDGWICK:**

- Members please remember at the end of the month, the CTA will be changing from Sedgwick to The Reed Group when dealing with FMLA and short-term disability.
- Members who are renewing FMLA or on FMLA, please keep up with your paperwork. When taking FMLA please keep up with the hours and days you use. When we are injured at work and going IOD, we will be dealing with **Corvel**. So, let's make sure we stay on our toes and be mindful of our situations during this time.

#### **TRIP TO SPRINGFIELD:**

- Both Presidents (241 & 308) have discussed a few things and think it is time to head down to Springfield and start our fight.
- The RHCT have several things that need and must be addressed, from and for the retirees to the full timers, to the part timers.

### TRIP TO SPRINGFIELD (cont.):

The RHCT and the pension must be addressed. The next issue was the disparity in pay that affects Maintenance Brothers and Sisters. As we head into negotiations, I think we need to apply pressure on as many areas as possible but keep in mind, the deal that gave the other unions the wage increase was made in Springfield. I think timing has never been better to address our concerns.

#### **EXPEDITED ARBITRATION:**

- Expedited Arbitration was held this month and the Local took (64) cases/grievances over to be heard winning (47) in some form. Labor Management will be taking place in the month of September for CTA and Pace. If you have any issues or concerns please share them with your rep so we can address them in these meetings.
- > No Pre-Arb was held in the month of August, but will resume in September.

#### **SLEEP APNEA:**

- This Local is ready to take on the fight of how CTA diagnoses our members with "Sleep Apnea".
- In 2012 the FMCSA (Federal Motor Carrier Safety Administration) was provided with recommendations from the Advisory Committee and Review Board relating to the issue of obstructive sleep apnea. These recommendations included testing where there was a BMI (Body Mass Index) over 35 or a certain neck size. This was to be an absolute standard. However, even in that case, the recommendation, notwithstanding this absolute standard and mandatory testing, was to grant a conditional certification for 60 days pending a sleep study and then another 90 days if the employee had sleep apnea to afford the employee the opportunity for it to become under control. This is very significant as it relates to the reasonableness of the policy that Concentra on behalf of the CTA has adopted. These were recommendations and were not regulatory guidance.
- Then in 2015 Legislation was enacted, requiring formal rulemaking in this area rather than regulatory guidance. As a result, the FMCSA (Federal Motor Carrier Safety Administration) pulled these recommendations and never passed formal regulations in this area. But again, the important part, even if (BMI Body Mass Index) is considered, there is not any support for taking persons out of service on this basis alone, based upon these prior recommendations.

#### SLEEP APNEA (cont.):

- Moreover, on January 12, 2015 the FMCSA (Federal Motor Carrier Safety Administration) issued a bulletin to medical examiners on this issue. I have attached a copy. First, the ability to operate is limited to cases of "Moderate-to severe OSA (Obstructive Sleep Apnea)" as defined by an apnea-hypopnea index of greater than or equal to 15 BMI (Body Mass Index) alone would not demonstrate this.
- Second, the FMCSA (Federal Motor Carrier Safety Administration) does not recommend that a policy be adopted that requires employees with a certain BMI (Body Mass Index) or neck size to undergo a sleep study. Instead, it is the recommendation that a Medical Examiner exercise his or her judgment in deciding whether to refer individuals based upon all the objective factors. To include sufficient additional information including that the Medical Examiner has sufficient experience in diagnosing sleep apnea and recognizing **risk factors** that may support a diagnosis of OSA (Obstructive Sleep Apnea) that warrants testing.
- Third, the FMCSA (Federal Motor Carrier Safety Administration) does not recommend relying on merely one factor such as a certain BMI (Body Mass Index). The Medical Examiner should consider other symptoms as well as risk factors, all of which must be documented. Based on the law, Local 241 will be taking the fight to CTA and Pace and requesting to fix every member who has been harmed.

#### PACE:

- PACE Southwest will have two dates of negotiations in the month of September as this team works hard to bring the members a respectable contract.
- PACE West, remember to write up all buses that are unsafe and also make sure the Union is aware of your write up.
- PACE North Shore, I will be looking for a "Steward" for this location in the upcoming weeks. Please watch out for the bulletin at this location.

#### **THINGS TO REMEMBER:**

- You can renew your CDL (Commercial Driver's License) one year in advance please do not wait until the last minute. When renewing your CDL, please have your birth certificate and please **do not** check interstate for medical if you don't need it. If you need help or some study material please call the Union office.
- Please check all Beneficiary information and make sure all your information is updated with the Union, CTA and the Pension Office.

#### THINGS TO REMEMBER (CONT.):

- In the month of November, we will be allowed to wear a hat of any branch of the military, please watch for the bulletin.
- There is no reason a manger should ever deny your request of Union Representation. If you are required to fill out an accident report, they will notify the Union but will not hold up the interview for a Union Rep as well as a miscellaneous report, they will not wait on the Union. If a manger is not respecting your request, please let an Officer of the Local know, so we can address this situation.







- ★ I have spent time making sure the flights, Hotel Stay, and meals were prearranged for all 27 Delegates.
- ★ A shuttle to and from the airport and The Convention to transport our Delegation has been verified.
- ★ In order to stay on top of the Convention, I spent the last 2 Saturday's in my office in order to complete all the work associated with being the travel planner for 27 people headed to a Convention. We will arrive two days before the Convention starts. As far as where I'm staying, I gave the Local 241 a reimbursement of the difference in the hotel stay. 

## 2<sup>d</sup> Vice President Tanno Muhammad September 2019 Report

I would like to start by saying, Peace and Blessings to Local 241 members; I hope you and your families are in good health and in the best of spirits.

As the  $2^{nd}$  Vice President, I have the responsibilities to represent the Local and its members assigned by the President.

During the last "Mass Membership Meeting", I attended the "Delegate" election and now we are preparing to make a statement at the 2019 59<sup>th</sup> International Convention. Last but not lease, I would like to congratulate all participants and all of the winners, see you in Las Vegas.

On August 9, 2019, I attended disciple hearings 567- CTA (Chicago Transit Authority) Headquarters.

## PREGNANCY ACT: PUBLIC ACT 98-1050: EFFECTIVE January 1, 2015

In the current workplace, laws did not adequately protect pregnant women and new mothers from workplace discrimination. Lawmakers noted that pregnant women

and new mothers were often forced into unpaid leave or fired, despite the fact that employers could often make reasonable accommodations that would allow them to continue to work. Because women make up nearly fifty percent of the Illinois workforce and more than fifty percent of those women are for bearing children, this impacted thousands of Illinois citizens. Some of the problems that women faced without reasonable accommodation included lost wages, unemployment, lost opportunities and benefits.

By providing pregnant women with reasonable, temporary accommodations can lead to increased productivity, retention, and morale while decreasing re-training costs and health care costs associated with pregnancy complications.

## **TENTATIVE AGREEMENT (Pregnancy):**

- Female employees delivering a child shall be entitled to 6 weeks paid maternity leave.
- Employee partner shall be entitled to 1-week paid maternity leave; both adopted employee parent shall be entitled to 2 weeks of paid maternity leave.

I also met with Safety Department's General Manager Rovaughn Graham and 74<sup>th</sup> Street Manager Todd regarding 47<sup>th</sup> at Lake Park terminal. Thanks to Leonardo Romano for repairing the restroom, cutting shrubs and talks on fencing and lightening over the bathroom.

WE ARE NOW WORKING ON 79<sup>TH</sup> AND 69<sup>TH</sup> RED LINE STATIONS FOR PROTECTION AND SAFETY OF OPERATORS AS WELL AS THE GENERAL PUBLIC. WE ARE ASKING FOR POLICE OFFICERS TO BE VISIBLE AND RIDE THE BUSES IN HOT SPOTS.

On August 12, 2019, President Keith Hill, 1<sup>st</sup> Vice President Woodrow Eiland and myself 2nd Vice President Tanno Muhammad attended Arbitration hearings at CTA (Chicago Transit Authority) Headquarters. We took 64 cases: seventeen (17) lost and forty-seven (47) wins, with no cost to the membership.

On August 15, 2019, all of the Officers went to Pace West Division Bus Garage and passed out Contract Books-January 1, 2016 -December 31, 2021. We also had a brief "Rap Session".

On August 22, 2019, I visited the Training Center located at 1120 E. 89<sup>th</sup> Street, Chicago, IL. I learned to respect the work more, that our Mechanics and Servicers

are doing. As I walked around talking to our Local 241 Maintenance Instructors in the Training Center and observing how they are teaching about dangerous and harmful chemicals used for cleaning the buses. I'm also respecting the Mechanics technical equipment and just having the intelligence to continue preparing safe bus operations for the general public. **LAST BUT NOT LEASE**, after witnessing a day alongside the Maintenance Instruction Department, it takes more than just operating a bus. I just wanted to acknowledge the good work that the Mechanics and Servicers are doing. In spite of knowing that our Local 241 Maintenance Instructors are training all Local 701 Union personnel that are being paid \$47.35 per hour.

I visited all bus garages and assisted in writing and updating grievances. As I walked in 3 garages to find out our operators might not fully understand General Rule Book on "Horseplay", "Name Calling" and "Profanity", is not permitted in the work place. Since 1986 I have been working for Chicago Transit Authority. My Local 241 members, AP1601 on "Bullying" and "Harassment" in the work place is real. The Executive Board and Union Stewards have been intervening and stopping the discipline and discharges.

Once again please read GENERL RULE BOOK -Rule 14, "Personal Conduct" page 4, 5, GENERAL BULLETIN G68-08 AND AP1601.

On August 26, 2019, I attended Step II grievance at 567 West Lake, Chicago, IL, CTA Headquarters.

## **DRUG HEARINGS:**

7 drug hearings: 4- resigned and 3- SAP Substance Abuse Program. It has been brought to my attention that the Collector in the garages is leaving sample bottles exposed, employee's urine bags not sealed and unattended. FOR ALL LOCAL 241 MEMBERS, PLEASE MAKE SURE THE AREA IS CLEAN.

- > Check the on the CCF (Custody Control Form).
- Show you that the seals on the urine specimen bottles are intact.
- > Break the seal on the urine specimen bottles in your presence.
- $\succ$  At least 45ml of urine.
- At least 15ml in the collection container, into urine specimen bottles to be split.
- > Place and secure the lid/cap on the bottles.
- > Seal the bottles by placing the tamper-evident bottles seals over the bottles.
- > Write the date on the tamper-evident bottles seals.

On August 27, 2019, I attended a "Special" Pension Meeting, along with President Keith Hill, Recording/Financial Secretary Treasurer Toi Bowers, 1<sup>st</sup> Vice President Woodrow, ABA Maintenance Marqueal Williams and Executive Board Member Tiant Gatewood.

## Pregnancy Act-Attachment

Effective January 1, 2015, the Illinois Pregnancy Accommodation Law provides greater protection for pregnant employees. The new amendment to the Illinois Human Rights Act applies to every employer in the state with one or more employees, just as the law concerning disability discrimination and sexual harassment does. (Some other provisions of the IL Human Rights Act apply only to Illinois employers with 15 or more employees.) The law covers workers (full-time, part-time and those on probation) and job candidates who are pregnant or who become pregnant.

## **Illinois Pregnancy Accommodation Overview**

The Illinois Pregnancy Accommodation amendment requires employers to make reasonable accommodations for a pregnant employee even if her impairment does not meet the official test to be determined a "disability." This is a change from prior disability discrimination laws, which did not cover accommodations for most pregnant employees, who were otherwise healthy. Under the law, Illinois employers may be required to make accommodation for virtually every pregnant employee, depending upon the job. The law expands a pregnant employee's entitlement to accommodations based on pregnancy, childbirth and "medical or common conditions" related to pregnancy or childbirth.

## **Reasonable Accommodations Required for Pregnancy**

Reasonable accommodations under the law may include assistance with manual labor or heavy lifting. It may also include providing a chair, bar stool or other seating for the employee while working. In many cases, reassigning an employee to a different position temporarily is a reasonable accommodation. So is allowing the employee to opt for a "light duty" assignment, or reassigning certain tasks to other employees. Allowing pregnant employees more frequent bathroom breaks is a common accommodation. Depending upon the employee and circumstances, it may also be necessary to allow employees more frequent breaks to drink water or consume snacks (or to allow water and snacks at the work station.)

## **IL Pregnancy Accommodation Law Requires Leave**

The Illinois Pregnancy Accommodation law also requires employers to grant leave to a pregnant employee, whether that is for doctor's appointments, a temporary medical complication, bed rest for the entire pregnancy, or time off to recover from childbirth. The employee is entitled to return to her job when she is fully recovered. This is a major shift for many employers, who only granted leave for medical disabilities and often required that employee meet the conditions for federal FMLA.

## **Employers Cannot Require Accommodations or Leave**

An Illinois employer cannot force an accommodation on a pregnant employee who has not requested one – even if the employer feels the accommodation is in the best interest of the woman, her baby or the business. For example, an employer cannot unilaterally reassign a pregnant woman to a less visible job or force her to take leave before she is ready. Nationwide, up to 67% of pregnant women work, many of them right up until the last month of pregnancy, according to the National Women's Law Center. The EEOC reports that charges of pregnancy discrimination increased 71% between 1992 and 2011. Reasonable accommodations vary according to the employer's size and resources, and the law does allow employers to deny any accommodation that is "prohibitively expensive or disruptive." However, the burden of proof is squarely on the employer to prove that the accommodation would negatively affect their business. The nature of the business and its resources are key factors in this determination.

## **Limitations & Posting Requirements**

The Illinois Pregnancy Accommodation law does not require an employer to invent a new job for a pregnant worker, if none exists. Nor does it require the employer to fire a worker with more seniority, to give that job to a pregnant employee. However, it does require that employers make reasonable accommodations for pregnant employees, up to and including purchase of special equipment. Illinois employers will need to update their Human Rights posters in 2015 to conform with this law.

## Assistant Business Agent – Maintenance September 2019 Report

My name is Marqueal L. Williams and this report shall reflect the events in the Maintenance Department at the CTA, PACE and Operators at First Transit. Incorporated in my report is the Southside Maintenance and Northside Maintenance Report. These guys give reports every month and is never issue on the property.

#### Judgement Calls on Road Calls

Mechanic and Servicers, when you are on a road call for a Dead Motor, Flat Tire, Fumes, Roaches/Bed Bugs, E'-Stroke/Brakes, and you decide that the bus is in need of a Tow, **the judgement call is totally yours.** 

Many Maintenance ask the question if Bus Operators' can't drive the bus with roaches why they think we can? The answer to that question is our First priority is to the Riding Public, not to have roaches or bed bugs on the bus, not to inhale fumes, remember you can order a Dust Protection Coveralls it goes up to size 6XL. Second is the Bus Operator working space, the operator is in that seat all day, if the operator have a problem with his/her working condition another bus will be ordered. Maintenance Life or Transportation Life will not be jeopardized in order to save the Chicago Transit Authority funds. If you are one of those diehard employees that likes to save the company money and you make the judgement call to drive that flat tire back to the garage and the bus catches on fire or while driving that bad brake bus you kill a family of five, then that is the judgement call you have to deal with.

When you go on a Road Call make sure you know what that road call is for, you should always bring the Company Cell Phone with you, that is located in the office, if the office do not have a phone that you can take for Road Calls please let your Union Rep know, and we will get one for that location.

#### A/C In The Garages

In my August Maintenance Report I gave updates on when the garages will have the A/C repaired, Kedzie, Chicago Ave, 74<sup>th</sup> and 103 have been repaired.

#### First Transit

Local Union 241 have Para-Transit as well, First Transit Operators deals with a great adversity of the medical riding public. If you are being assaulted on your route by your clients, you need to radio dispatch, and then do a report when you get back to the location, also Call Local Union 241. If your client cannot control their bowel movement, you should not have to endure that type torture, and you most defiantly do not have to clean any type of bio hazard. No matter how mentally or physically challenged your client are you have rights as well, if that client needs a PRA to monitor them, then that family have to spend the money if they want the ride. The fight starts with a simple phone call.

If you get into an Accident or Incident your job is to radio dispatch, do a report. If the client fills out a 10-24 this should be done when the client get on the bus, then you should always contact dispatch before moving that bus, which the client filled out a 10-24. If you wait until something happen and fail to call dispatch you will be disciplined.

#### Maintenance Grievances

For the First Time we took Bus Servicers Apprentices Discharge Grievances to Expedited Arbitration, the Bus Servicer Apprentices are under a (3) three strike rule, and they cannot file a

grievance on any discipline except the discharge offense. We took three discharges and won one Apprentice his job back. The Major victory in that expedited Arbitration was a grievance that LaMont Coleman wrote, Adam Klimas was given a direct ordered by Management to preform Brake work that is normally done by 701, Local 241 won that grievance in Expedited Arbitration, this is not the First Grievance of this matter I won during Arbitration, we won another on with Jerome Lines doing work that is normally perform by 701 in Pre-Arbitration. The buses are the same, Skill and Knowledge is the same and we have the Same 241 Maintenance Instructor that trains 701 Mechanics, but the pay is totally different.

We have (2) Two Maintenance Expedited Arbitrations for Bus Servicers Apprentices scheduled for September, we have (2) two Regular Arbitration Scheduled for October and November, when we win them that will bring all our Bus Servicers that are Terminated Back to work. And we are in the process of Scheduling dates for Pre-Arbitration for (2) two Mechanic that are terminated.

#### Maintenance Test Scores

On May 6, 2015 at a Labor/Management the Union asked the Authority did they lower the standard for the Maintenance Mechanic entrance test. And the answer by Mr. George Cave lie was yes from 75% to 70%. I filed a grievance on this matter and right before arbitration CTA raised the standard. On August 26, 2018 I have been told by Several Maintenance Employee that they failed the entry test and now are being call to the next step of testing. I filed this grievance on June 1, 2015 and the grievance number is 15-0483, this grievance was passed by the membership to go to arbitration, I will be enforcing this grievance. I have sent the request for a Labor/Management Meeting upon the discovery facts of that meeting I will be filing another grievance.

- I am currently looking into the issue that 701 is attending A/C training when our own 241 mechanics are requesting the classing and I'm also looking into 701 doing our A/C work.
- 2. The Dummying down of the Testing, and the Lowering of the Test Scores.
- 3. Garage Pick
- 4. Training
- 5. Labor/Management Meeting.
