



REPORT OF THE PRESIDENT B/A KEITH D. HILL SEPTEMBER 2019

Below is my report for the month of September 2019, presented to the Executive Board on September 18, 2019 and the Members on October 1, 2019 during the Mass Membership Meeting.

PILOT PROGRAM:

- The Union has been in on-going conversations with CTA for a few months about what we call a working suspension. The CTA will be trying the program at two locations: Chicago Ave. and 74th Street garages. If you are charged with anything other than a safety or an accident you will receive a working suspension.
- If you receive a one-day suspension, you will be allowed to work your run but the suspension will reflect on your record.
- If you are on a violation that will lead to a CCI and probation, you will be allowed to work up to the hearing. The hearing day will count as one of your suspension days and you will be allowed to work the other two days.

This process will not interfere with the grievance process or any dispute you may have about the violation, the member and the Union still reserve the right to fight all violations. This program will be reviewed after ninety days with the hope of pushing it at all locations. New developments will be brought to the members as things move forward.

REED GROUP:

- The Reed Group has started the take over from Sedgwick. The Union was hoping for a smooth transition but there are a few bumps. We have about seventy (70) members whose seven-day sick claim was mixed up in the transition. If you have not received your claim please reach out to the Union. The seventy (70) members will be paid in the upcoming weeks. The disability benefits pay was also paid incorrectly.

REED GROUP (cont.):

- Our disability benefits amount will vary based on your years of service, so if yours has not been corrected or you are still being paid incorrectly please reach out to the Union. Also, members with FMLA who might be having trouble setting up a profile, we are more than willing to assist you with this, please call the Union office. If you come across anything that you may have a problem with please notify us.

PRE-ARB:

- The Union held Pre-Arb in the month of September, we took over twenty (20) cases winning ten (10) out of the twenty (20). The ten (10) cases that were not granted will stay open and active until their day of arbitration.
- Pre-Arb is a way that the union saves this membership money. There was no Expedited held in September but will resume in the month of October.

PACE SOUTHWEST CONTRACT:

- We would like to thank the Pace Southwest Contract Team: Pamela Goffin, Susan Quainter, Russell Bailey, Michael Evans, Gary Ozienkiewicz, Danielle Powell, Kempton Shine and Caesarie Montgomery.
- A little under six (6) months, we are able to bring the Brothers and Sisters of PACE Southwest a respectable contract.
- This administration can stand proud and say we have delivered another contract with no loses or give backs and bringing them one step closer to our other PACE locations.
- This contract also respects the craft of our Brothers and Sisters who are mechanics and give them a separation they much needed from the operators to bring them closer to the other PACE mechanics.
- We also resolved all open grievances dealing with PACE Southwest in some form.

I would like to thank the entire negotiating team for their hard work and voicing the concerns of the Pace Southwest membership.

EXTRA BOARD:

- For years the Local has attempted to address the seniority problem on the extra board. This is not a problem at just one location; this is a system wide problem.
- We will be meeting with the CTA and the three (3) clerks to try to nip this in the bud and gain control of seniority for our extra board operators.

EXTRA BOARD (cont.):

- On the extra board, if you are scheduled a run before 8:00am, the person cannot get off before you. If you are scheduled a run after 8:01am, the person can't check before you.
- No day off person should be scheduled a run before the full-time extra board is complete.
- The clerks are only following instructions from the CTA, so please don't blame them, our fight is with the CTA for giving the order to violate our members. But this will be brought to an end.

PENSION:

- Are you ready to fight to see more of your paycheck? Are you ready to stand up for our future benefits? The time has never been more right to take the fight to Springfield to fight for our check and to make the changes needed to our pension to stop the bleeding.
- We as members are faced with another increase in January of 2020 that will make us one of the highest contributors in the nation.
- This increase will have us paying 13% of our earnings into the pension. Don't get me wrong, we are not out to change the benefits we receive from the pension plan, only what we are contributing into the plan.
- We have been told if we make key changes like changing the 10-year window to 20 or 25 years, we could lower what we are contributing into the plan.
- Another part of the law that needs to be worked on is the plan designed to always increase but not decrease. For example, we had two good years where no increases were needed and was recommended to lower, but we couldn't because the law doesn't allow it.
- The plan is only 52% funded and is required to be up to 60% in ten years fully funded. The plan is on target to be fully funded so **NO CHANGE WILL AFFECT ANY RETIREE CURRENTLY ON PENSION OR ANY ONE PLANNING TO GO ON PENSION. THE PENSION IS A PROMISE WE ALL WANT, DESERVE AND WILL GET.** More about this will be coming in the future about the fight we need to do, so get ready.

This administration has taken the cost and the voice of our retirees and members serious and we are ready to bring this fight to Springfield.

First let me say, for the second year in a row this administration can say we have not allowed the plan to be increased on our retired Brothers and Sisters, we have also held the line on the index pricing as well. The Retirees will not see an increase on any part of their health care. We understand you have not had a raise, everything has gone up and your check is getting smaller; give us more time we are working to address and fix.

PENSION (cont.):

- The fight in Springfield with the RHCT is for all members retired, full and part time; we all have issues that need to be addressed.
- This is another area that we think the members can use some relief and contribute less.
- Part-Timers we need to take you out of this benefit. We have a major road block ahead of us, but together we will win this battle so remember be on the lookout for the call to ride to Springfield and let's fight for our checks.

PEST CONTROL:

- The month of September, I received a large number of complaints about pest being on the buses.
- Working with the Assistant Business Agent of Maintenance, the entire fleet will be exterminated.
- This will be ongoing, please if you are experiencing or see something say something.
- This is our work area please work with us to keep it pest free.

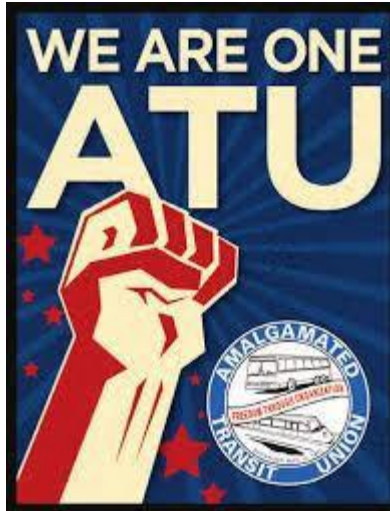



For the month of September, I was assigned to assist the Northside and Westside garages with discipline and in addition to doing various duties assigned by President Keith Hill as well as corresponding 1st Vice President duties.

I attended discipline hearings at Pace Southwest. The morale has gotten so bad at that location for the drivers. Managers are trying to charge for any and everything. **Pace Southwest Drivers-Beware!** Please fill out all reports and call in like you supposed to, by way of their rules. Don't let management talk to you any kind of way. If this happens, call your Union Officials.

I also attended the "Fall Pick" meeting along with 2nd Vice President Tanno Muhammad. We talked about late reliefs on the street. It seems that CTA cares more about paying out the money, if they have to pull-in and not the operator's safety. Then we talked about turning all runs into 8.0 hours or better. They did have a problem with it, but we have to go through the **"Budget Department", first**. Planning Department thought it would be a good idea.

We talked about long swing shifts and we were told that it has to be done at the contract table, **And It Will Be!**

The second part of the meeting, we talked about the “Supervisor’s Pick”. Let’s just say this, we were promised 96 positions at the last contract in 2018. We received 94 positions with 2 still missing, that we were told we’re getting them any day now. **The Union Just Wants To Get What We Were Promised!**

Sorry for the inconvenience, but if **“We Don’t Stand For Something, We Will Fall For Anything!” THIS IS NOT TO HARM ANY SUPERVISOR!**

We also talked about getting the caps back for the Supervisors and Instructors. We were told that they would look into it.

Bus operators, upper management is always trying to put us up against each other, please stand strong.

People at Pace West, please stand strong. We are trying to get management to do better as far as the morale, also. If the Union information doesn’t come from a Union Official, don’t believe it!!!!!!!!!!!!

I attended a Pre-Arbitration hearing at CTA Headquarters located at 567 West Lake Street with President Keith Hill, and we took approximately 20 cases and brought back 10 members at no cost to the membership.

SWING RUNS AND LATE RELIEFS

On September 12, 2019, I attended a meeting at CTA Headquarters with 1st VP Woodrow Eiland, Attorney Katherine Lunde, Vice President of CTA Patricia Miller and Planning and Support Kimberly Hawkins. We talked about how we can possibly cut down on the swing runs and late reliefs.

UNIFORMS

CTA will be looking for another uniform carrier, because the RFP (Request for Proposal) will be going out before the end of the year.

SUPERVISORS

The Supervisors have not picked. We have 94 Supervisor positions but we were promised 96 Supervisor positions, so please be patient and hopefully have answers before September 20, 2019.

I VISITED THE GARAGES:

- ✳ 74th Street Executive Board Member Rodney Taylor and Union Steward Michelle Townsend are still working hard on keeping members employed.
- ✳ 77th Street Union Steward Perry Thornton and I dealt with an alcohol discipline.
- ✳ Chicago Avenue Union Steward Kelvin Gilkey had a discharge hearing that I assisted with.
- ✳ Kedzie Union Steward Mario DeMello is working on keeping our members from being double charged.
- ✳ Forest Glen Executive Board Member Jack Bayer and Union Steward Orlando Robinson were passing out and collecting Contract Proposals.
- ✳ North Park Executive Board Member Erek Slater and I worked on saving out youngest members.
- ✳ Pace Northshore Union Steward, President Keith Hill and I worked on updating grievances.

Assistant Business Agent – Maintenance October 2019 Report

My name is Marqueal L. Williams and this report shall reflect the events in the Maintenance Department at the CTA, PACE and Operators at First Transit. Incorporated in my report is the Southside Maintenance and Northside Maintenance Report. These guys give reports every month and is never issue on the property.

Old Business from Last Month Report

- **Roaches on Buses:** The entire fleet at 103rd Street was done with a stronger repellent, also the entire garage was sprayed as well.
- **701 doing our A/C Work:** Garage Manager was sending buses to the Shops with an open work order to do the A/C work. Shop Manager was processing the work order and having the 701 Mechanic to do the work, CTA agrees that if any Garage Manager send the bus to the Shops for standard A/C work that the Shop Manager will send that bus back to the garage.
- **Labor Management Meeting:** The Union Requested a Labor Management with the Chicago Transit Authority, Mechanical Officer Thomas Matuszak has been off work and General Manager Bryan Robinson is the acting Mechanical Officer and he's been on Vacation and return on September 17, 2019 so North Side General Manager Jeff Edwards is the Acting Mechanical Officer, who requested that any executive decision making should be made when Bryan come back from vacation. Local 241 was at the International Convention from September 22 – 28, 2019 so in October we will set a date to meet with management.
- **Garage Pick:** This Pick will be a garage pick.

Contract Proposals:

January 1, 2016 - December 31, 2019 is when the current Chicago Transit Authority contract expires. Local Union 241 Representatives are passing out Contract Proposals, YOUR INPUT IS ESSENTIAL in this collective bargaining efforts. Remember when working people come together, the sky is the limits. Union enables workers to negotiate for Higher Pay, Better Hours, More Affordable Health Care –

and Power! Please take the time out and fill out the proposal sheets, put realistic items, don't be afraid to ask for what you know other local have that CTA was willing to give to them.

Maintenance Test Scores

It has been confirmed by H/R that the test scores were adjusted and that made room for many more applicants to make a passing grade on the test. In 2015 when this happened the Union would not signed the Apprentice Agreement until they change the test score back and change the vacation pick back. Afterward Local 241 extended the Bus Servicer Apprentice Program to 2016. Now in 2019 the Chicago Transit reneged on their part of the agreement that was made back in 2015. We will filed a New Grievance on this matter and we also have the old 2015 grievance that we have never withdraw from June 1, 2015 and the grievance number is 15-0483. Like I said last month this grievance was passed by the membership to go to arbitration. When we have a Labor/Management Meeting this issue will be addressed and resolved in that meeting or through Arbitration Grievance Process.

Bus Extermination:

President Hill and ABA – Marqueal Williams have been on the CTA about the Roaches and Bed-bugs situation, some have infested into the garage area where we change our clothes, as I reported last month, this situation is and have been addressed. This is the results so far, 103rd Garage entire fleet and building has been done, and now 74th Garage been done September 15, 2019, next will be Kedzie Garage and 77th Garage. Also along with the extermination blitz the regular extermination will be done at all location on a normal monthly basis.

Garage Issues:

Tim Westhoff and Marqueal have been battling issues on the Northside, Tim Westhoff and myself had a Fire-drill at North Park and the issues there was Break Bus, this issue is resolved, Night Servicers Overtime, this issue is resolved, and Bed-bugs, we are to do a self-extermination and afterward we will get the bus number and have our regular exterminator follow up on it. Then Tim Westhoff and Marqueal Williams had a Fire-drill at Chicago Ave. We heard the issues of Washroom Showers, and our Janitors going on Road-calls, issue resolved, A/C Training.

LaMont Coleman and Marqueal have been battling issues on the Southside, LaMont Coleman and Marqueal had a Fire-drill at 77th Street and the main issues was proper equipment, if you need "any" equipment and you have told management please reach out to your Union, with just one conversation with Management the tools was ordered. At 103 we did a Fire-drill there, and the problems was Over-time, which was resolved, Contract Proposal was the major topic.

RHCT Meetings:

On September 17, 2019 President Keith Hill along with Tanno Muhammad and Marqueal Williams attended the Retirement Health Care Trust meeting, the agenda of this meeting was to make a decision for the funding of the Retiree Health Care Cost and oversee the Investment Return Funding Assessment.

This will be the Third Year in a Row that the Retiree Contribution will not increase and have actually decreased in the first two years, this plan is overfunded over 130%. In order to keep this fund over funded the decision was made to lower the rate of return assumption. The Officers and Executive Board next goal is to go to Springfield and lower the active member contribution percentage of the plan.

Medicare Advantage:

Humana Group Health Care have a plan called Medicare Advantage, Medicare Advantage pulls together all plans into one, Humana Administers the plan for Medicare. Things to take programs to take advantage of is the Telehealth nurse care management. Telehealth in 2020 MD Live, you can Facetime a doctor live, this is called a virtual Visit, this give you a greater comfort with using technology to manage health, and is a cost saving to use this option than going into a doctor office and improves the access without then need of a doctor appointment. Other Benefits are Meals on Wheel, Home Health, also Clinical Management for Humana is call 4 Star, and this plan is a bonus in year 2020. For more information you can actually visit the Humana Guidance Center in Evergreen.

The next Maintenance Pick will be a Garage Pick, the tentative dates are as follows:




