Something had to change. We no longer utilize an in house attorney and we are back to using one law firm. Additionally, the ATU International Vice Presidents/Trustees are establishing a new Internal Grievance Committee process. Our goal is to move grievances through the grievance procedure in a more efficient and cost effective manner.

As most of you are aware, there are a number of grievances still pending arbitration dates. The Trustees are working to find a resolution to this on-going problem. It's not magic, but better training, better
