



REPORT OF THE PRESIDENT B/A KEITH D. HILL DECEMBER 2020 & JANUARY 2021

Below is my report for the months of DECEMBER 2020 & JANUARY 2021 and will highlight issues from the year 2020 presented to the Executive Board for the Zoom Executive Board Meeting on January 27, 2021 and the Zoom Informational Meeting on February 2, 2021.

Brothers and Sisters,

I wish to again express my appreciation for all your hard work, dedication and personal sacrifice during this difficult time and situation. Let me assure you, your dedication and personal sacrifice in handling and rising to this occasion will not go unnoticed. During this time, we continued to move this city and suburbs, providing service to the first responders and those who are in need in the City of Chicago and Suburbs. We move people as they need to get to work and take care of their daily needs. There is no one second to none in what we do, we are the best at it and I **thank you.**

I want to **thank you** for the sacrifices you have made and the situations you have confronted and have handled as professionals each and every day. You have performed over and above expectation in continuing to make the City move. You have performed in a manner above and beyond what anyone could have expected, under these conditions. We have made certain our local politicians, CTA and PACE, never lose sight of the individual sacrifices you have made. Your efforts, sacrifices and professionalism have not gone unnoticed. You should stand with the greatest pride.

To my Brothers and Sisters who have been struck by this nasty virus and are on the road to recovery and those who have recovered, our hearts are with you and we wish you the best. As you recover, you are not alone, we are family. Members reach out, let others know so we can encourage and support each other. Please remember you are in our prayers. We are here to assist you if we can, please do not hesitate to call anyone in the Union.

The economic effects of this Pandemic will last for years, and there will be consequences for all working people. While there may be some light at the end of the tunnel, we must all recognize there are significant challenges before us.

- Our economy is broken and we have been fortunate not to have experienced layoffs or reductions, like so many of our neighbors. However, our fight for respect and dignity in the workplace is ongoing. The obstacles we will face in the future are significant and we have stood together in these difficult and unimaginable times. If we marshal these same efforts going forward, show the strength of unity, and not let ourselves get distracted like so much of the public that is listening to and relying upon untruths intended to divide us in every way. We can show that our Union and unity will prevail.
- I am convinced our unity can bring about significant change and overcome any obstacles that may appear in our path.
- One of the hardest decisions we had to make this year, was to put this membership in a position to not be faced with a layoff. That wasn't a sole decision, it was a strong collective effort from your Officers and Executive Board. We believe from our 50-year members to our day-1 members, all deserve a chance to provide for themselves and family. One brave move paid off for this Local and our membership as we keep everyone working during times when ridership was at its lowest and no tax revenue was generated as normal. This fight is not over as we focus on the future and promise to do all we can to protect this membership and all departments.
- During the current pandemic CTA and PACE bus operators have kept the City and suburbs moving, reporting for work each and every day, but yet during this same period have been subjected to increased verbal and physical abuse for attempting to ensure the safety of the passengers for whom they have responsibility over. These attacks have ranged from physical assaults on drivers and passengers to paint ball attacks on buses and bus operators to carjacking and stealing of our cars on the CTA property. Local Union 241 will not take this lightly and will continue to fight and make noise about our safety.
- Bus Operators driving their regular routes have been attacked or had their buses attacked for no apparent reason. These attacks not only imperil the bus operators and the riding public by instantly creating a dangerous situation, but has the potential consequence for causing serious accidents and injuries. It will not only affect the riding public, but innocent by-standers and other drivers who may be involved in an accident caused by these unprovoked attacks. The perpetrators apparently believe they are free to act out because they believe they are not subject to significant penalties, much less prosecution.
- Before the pandemic, we had a Bill pending in Springfield to protect ourselves, we will reintroduce this Bill again. This administration firmly believe that no one can protect us better then we can. Along with the Bill, we are pushing for new and better safety features on all buses and at the garages we work at and park. We will fight to be protected from the parking lot to the end of the line, as we do our job or getting off work walking to our cars. We will stand and fight this as one, ATU 241.

In closing we cannot **thank you** enough, for your support and sacrifices. Have a safe, strong and healthy 2021. Remember together we stand divided we fall and we are a strong Union that have no intentions of falling. One ATU 241 strong!!

- The CARES Act (Title XII of Division B) includes <u>\$25 billion</u> for public transit formula operating and capital grants to prevent, prepare for, and respond to COVID-19. The Bill provides that the Federal Transit Administration (FTA) distribute the transit funds proportionally based on the ratio of funding of four specific programs: urbanized area formula grants (49 U.S.C. § 5307); rural area formula grants (49 U.S.C. § 5311); state-of-good-repair (SOGR) formula grants (49 U.S.C. § 5337); and growing/high-density states formula grants (49 U.S.C. § 5340).
- In general, transit law requirements (Chapter 53 of Title 49) apply to these operating and capital grants. However, notwithstanding transit law limitations, these funds are expressly available for operating expenses to prevent, prepare for, and respond to COVID-19 beginning on January 20, 2020. These funds are available to reimburse public transit agencies for operating costs to maintain service and lost revenue due to the coronavirus public health emergency, including the purchase of personal protective equipment and paying administrative leave of operations personnel due to reduction in service. Although these specific operating expenses are outlined in the Bill, other operating costs may also be eligible. These operating expenses are not required to be part of state-wide or metropolitan transportation improvement programs or state-wide or long-range transportation plans.
 - December 27, 2020, the Coronavirus Response and Relief Supplemental Appropriations Act of 2021 (CRRSAA), Similar to the CARES Act, the supplemental funding will be provided at 100-percent federal share, with no local match required. Funding will support expenses eligible under the relevant program, although the Act directs recipients to prioritize payroll and operational needs. I point this out because we are not out of the woods and to remind the members, ridership is key.

COVID-19 VACCINATION:

CTA and PACE operators are both in line to start the Vaccination on January 25, 2021 in the 1-B group. Both agencies have agreed to keep it optional for the members. No one will be forced or disciplined for not taking the shot. We are still waiting to see how PACE will roll things out for our members. PACE has not identified if they will have a location or will be doing things on their own. CTA is doing the same but has identified a few ways they plan to get it to the members. As things become more concrete, we will let the members know. If you choose not to wait and decide to go ahead and make your own appointment, please follow the link below.

Pension:

- I'm happy to say, under this administration this is the second year we will not have a pension increase. This is something we can smile lightly about and prepare to do more work on, no increase is good but we have work to do in Springfield.
- I will keep saying to this membership, the time is right to go to Springfield and lower the contributions we are paying and still keep this pension going strong so we all can enjoy the fruits of our labor. 2020 was a roller coaster year for the stock market but we finished strong with a running market in a positive way. This fight in Springfield is all of our fight and it's a way for us to see more of our check, it might not be an easy one but the time is right. No battle in Springfield is an easy one or an overnight fix. It takes work, time and dedication to our cause and I know this membership is ready to lay the ground work and get this going. The reward will pay us two-fold in our paychecks and in our pension checks. Let's get ready to bring Springfield to Local Union 241.

Retirees:

- For the third year in a row this administration can say that they have made sure that the retirees had no increase in their medical. Not only did this administration hold the premiums, we also stopped the index, a hidden cost, from increasing. No administration has ever made the pension board look into this cost; it was increased every year with no question.
- This administration made them bring it to the table and fought to make sure that cost was not increased on our retirees. Our work is not done as we continue to work to better the retiree's quality of life.
 - Also, I would like to remind the retirees to look into their beneficiary on their policy, as time go on, we might forget to change or update this.
 - Local Union 241 will be trying to reach out to its retiree's base to ask questions on the healthcare provider and things we can do to make it better or things we can try to change. Also, in the prescription plan as well, so please help the Local out with this so we can make sure things are better and easier for those who paved the way for us.

CONTRACT:

- Contract talks with both Locals and the CTA are planning to resume. Local Union 241 Officers are looking forward and eager to get back to the table. Our members deserve to be rewarded for putting themselves on the line over the last year.
- Local Union 241 sees some changes that need to be made to some proposals and adding a few to better protect this membership in the future. Some changes need to brought to the table about our quality of life and changes if we have to work under these conditions again without waiting on congress or others to help our cause.

PRE-ARBITRATION AND EXPEDITED ARBITRATION:

- The Local has had a good year during these rough times in both of these areas. Although we had to change the area in which we held both, we had success.
 - The yearly case total for Expedited Arbitration Cases were (1,133) total grievances winning (632) in some form. (285) cases were MOOT meaning the member didn't lose anything or it was no standing discipline on the members' work record. We lost (216) cases where the arbitrator upheld the CTA and the discipline on the members record.

In this arena we were able to return \$1.7 million dollars to the members who lost pay or were held out of service.

- **Pre-Arbitration** We took over (225) cases dealing with discharges or contractual violations. These are cases that might not or have been recommended that we can't win in arbitration:
 - We won a total of (172) cases in the year of 2020. Also, in 2020 we lost a total of (62) members to discharge. This was not our lowest under this administration but it's something we are proud of and I'm truly proud of the work our Executive Board and Stewards have done by any means to keep members working.

PACE or CTA, our Executive Board has done great work in 2020 and let's get ready to step up more in 2021, take a bow for the great work. I would also like to thank all my Officers for working with me in this arena, First Vice-President Woodrow Eiland, Second Vice-President Tanno Muhammad and ABA Maintenance Marqueal Williams, all of us take this arena serious and take pride in seeing results for our members and we will continue to put our best foot forward for you.

This is a repeat but I can't say this enough!!!

- I would like to commend the Executive Board, Stewards and our FRST (Financial-Recording Secretary-Treasurer) Toi Bowers. In April of 2017 this administration took office with a little over \$650,000 in the bank and a large amount of unpaid bills. Toi took the job and grabbed it by the horns to safe guard the members' money. The Board stepped up and controlled the spending and made wiser and some unpopular decisions. After taking office and receiving our first audit and having several recommendations to correct and fix things:
 - Like having receipts for petty cash
 - Not paying bills late
 - Better records of bills

Your elected Officers, Executive Board Members and Stewards promised to fix things under Toi's watch. I'm proud to say our FRST (Financial-Recording Secretary-Treasurer) has completed her 6th audit with no negative marks or corrections. Yes, this administration has grown this membership money in the bank by \$1.4 million to the tune of \$2 million and growing.

We were faced with several missing checks, although the bank gave us our money back, it just didn't sit right with the Officers especially our FRST. I am pleased to announce to the membership they caught the individuals and legal charges have been filed against them. I'm proud to have her by my side!!

I would really like to congratulate our FRST on her hard work and the great job she has done with the member's money and elevating Local Union 241 to a place we haven't been in almost five decades. To the Officers, Executive Board and Stewards take a bow and let's keep moving this Local forward and safeguarding things as well. The proof is in the paper and reports, great work all!!

LEGISLATIVE AGENGA FOR 2021:

- Our Legislation agenda was thrown off by COVID-19 in 2020 but we will need to pick it back up in 2021:
 - Safety, Pension, Maintenance and PACE must move forward.
 - We had a Bill carried in Springfield sponsored by The Honorable State Rep Thaddeus Jones that would require police on every bus. The goal is for us to get our own security team back in play. No one can care more about us then us. If you would like a copy of the Bill please reach out to the Union and let us email you one. This is one Bill we need to reopen and bring to the forefront.
 - Also, we need to address our pension, we are paying 13.24%. That is too high and taking up a big part of our paychecks although this is for us tomorrow, I think we could lower it and still meet our target and requirements with the pension.
 - Maintenance: We need to move aggressively forward to close the disparities in our maintenance department. This department keeps the system moving and they have a trade and should be paid equal as their counterparts that work in other shop departments. The other crafts and trades got a huge raise from a deal in Springfield and our guys deserve the same. So, in 2021 let's get ready to be heard and fight

This pandemic has opened the eyes of many about the role that public transportation play. Some of our PACE locations could use some help with more service on certain routes and address transit desserts for both agencies. Shields and other safety measures for both agencies must be pushed. Get ready 241, let's bring some noise!!!

RELIEFS:

- Local Union 241 is keeping the fight going to the CTA, demanding safer relief points. One relief point we are in heavy talks about moving is the 67th and Cornell. We have talked about a few options but nothing concrete as of yet.
- We also are having ongoing discussions about late reliefs; we have seen a reduction since taking office but still would like to see more. Also, during these times, we are being left on the street because the runs are not being filled. This is not to point fingers. The clerk has a very difficult task at this time, as well as our Supervisors in maintaining things so let's work with them.
- If an operator is called in the office for not checking for a relief, please reach out to the Union so we can assist you.

MISCELLANEOUS:

- During these times if you are on a bus and it has a bug/rodent problem, please give the bus number to the Union.
- If you need to push the silent alarm on a bus and you don't get a response please let us know, we will need the bus number and the street you were working at the time along with a timeframe.

Audits

ATU LOCAL 241 DATABASE

Grievances



Total Discharges



Mortgage Refinance

In May of 2020, we had a pending balloon payment that was due. The Executive Board voted to Refinance our mortgage at a lower interest rate. The option to pay off the entire mortgage still lies with the Membership. We will continue to keep the Members informed of all business transactions.



Local 241 Bylaws

Under this administration, the Bylaws have been re-established as the official "rules of the road." No longer will the Bylaws be circumvented. No more stipends.

External Check Fraud (Update)

At the beginning of the year, I reported to you that a number of our checks had come up missing from the post office in which they were mailed. Our per capita tax check and a Xerox check was fraudulently cashed after being intercepted from the post office. At this time, I promised the Membership that I would not "waiver in my resolve" to see this problem through to the end.

Outside of a few Members whose goal is to divide this Union, Local 241 stuck by this Administration. With the help of our President Keith D. Hill and Tia Ewing from FOX News, shedding light on our story, I stand before you today to say that Local 241 has been made whole. We have retrieved all monies lost. We have also received an update from law enforcement officials informing us that an arrest had been made in connection with the theft of our checks. This was an external problem. This was a breach that occurred at the United States Post office. I will keep the Members informed of any prosecutions and or trial dates.

Moving forward, I will continue to push for and implement stronger internal and external controls to safeguard this Local. Special thanks to Tia Ewing of Fox News for keeping our story in the public eye. Your help was greatly appreciated.

Sexual Harassment Training

In the month of December, the Officers, Executive Board and Stewards were given Sexual Harassment Training. This is a serious training. Just like our members have to take training our Officers, Executive Board Members and Stewards have to as well. This Local holds itself to the same standards as the members we represent.

P.P.E Donations

We are thankful for the people who continue to look out for the Members of Local 241. With a pandemic raging out of control, there is one notable person that made not one, but two considerable donations to the Members of Local 241. His name is Dr. Willie Wilson. When the Officers of Local 241 met with Dr. Wilson, I expressed the need that our Operators had and if it was possible that he could assist. He agreed that our Bus Operators needed protection and sprang into action. Dr. Wilson made sure that our Bus Operators and staff had the masks needed to keep themselves safe from COVID-19. This was just another big – hearted act of kindness that was shown by Dr. Wilson.



<u> COVID – 19</u>

The office has been updated and is now in line with CDC recommendations on health and safety regulations. We have installed temperature detectors and desk shields. Please remember to take your temperature and wear your masks when entering the Union office until this pandemic is over. This is for your safety and the safety of the office staff. We also continue to make sure that the office is clean and sanitized. Masks are provided for those who come into the office. These measures were taken to keep our Members and office staff safe.

Due to CTA staff working from home during this pandemic, many pay issues has arisen. I have resolved many of our Members pay issues including Covid – 19 pay issues (positive readings, child care and possible exposure), FMLA, Sick Pay, improper coding issues, The Reed Group and many more. In order to better serve the Membership, I continue to ask the Members consult their Union Representatives at their locations so that they can pass the information on to our officers.

This pandemic hasn't let up on us yet, please wear your masks as you are instructed to do so, by way of the CTA bulletin, when you are on the CTA properties.

WASHROOMS:

Please call control when you see or enter a dirty bathroom, so they can get it cleaned A.S.A.P. If you enter a CTA rail facility and try to the use the washroom, please be in uniform and show your I.D. If they refuse to let you in, call control and let them know and be sure to notify your Union Rep or call the Union office to report it.

CONTROLLERS:

Controllers are talking to the members any kind of way. Please remain professional and get their controller number, then fill out a "Report to Manager" form at the end of the day and give a copy to your Union Rep. We are in the process of getting a "Labor Management" meeting with the Control managers and their Vice President.

<u>SCHEUDLE ADHERENCE:</u>

Operators, please try to run on time or behind, because Supervisors are instructed by their managers to write you all up for running ahead of schedule. I know it's hard, but if you have 15 passengers (40 ft. bus) or 22 passengers (60 ft. bus), please notify control to cover yourself.

TALKING AMONGST CO-WORKERS:

Please watch what you say around your coworkers or management, because it can be taken the wrong way. We are getting a lot of calls from member against member complaints. EEOC Department is not on our side so, beware.

SUPERVISORS:

We are paying close attention to Supervision. We are getting a lot of complaints out of two of the three locations, about Supervisors working other cars instead of what they picked. That cannot happen! Supervisors can work all of the overtime that they want, but you have to work what you picked first (*That's why we have seniority*).

PENSION OFFICE:

We all are looking forward to getting back to some kind of normalcy of the pension office availability. The Union office and Officers are receiving a lot of members calling us, because they can't reach the pension office. Members we are still welcoming you to call the Union office if you can't reach anyone at the pension office.

REMEMBERING 2020:

2020 was a bad year for members being involved with COVID-19. Please keep your head up and continue to be safe.

2020 the Officers of Local Union 241 won a lot of grievances and money back in the members pockets; I hope 2021 is even better.

2020 discharges are at a low due to President Hill, other Officers and the Executive Board/Stewards members working diligently for the members of this Union.

We won a lot of Pre-Arbitration cases bringing back a lot of members, that we would have loss in regular arbitration.

As the 2nd Vice President, I have responsibilities to represent this Local Union and its members assigned by the President.

GARAGE VISITS:

I visited all of the bus garages, helping our members and assisting in writing and updating grievances. At North Park garage I withdrew a grievance and had an operator put back in service and assisted another member by withdrawing their discipline; I had a discharge hearing at 77th Street garages. In doing so I assisted 77th Street Executive Board Member Claudell Cain & Union Steward Perry Thornton; 74th Street Executive Board Member Rodney Taylor & Union Steward Michelle Townsend; Also attended a Janitorial discipline hearing with Executive Board Member Paul Tolson; Assisted Union Steward Orlando Robinson at Forest Glen garage and attended Step II Grievance meeting.

CRIME & VANDALISM ON CTA PROPERTY:

During these troubling times, please watch your surroundings. There has been a lot of car jackings going on in the Chicago area. Operator's cars are being vandalized and/or stolen off of the CTA lots. Local Union 241 will be working closely with Chicago Police Department in these high crime areas.

CONTRACT TALKS:

On January 21, 2021, contract began with Local Union 308, our Sister Union. We are waiting to meet with CTA.

REASONS TO BE A UNION MEMBER FOR NEW HIRES AND VETERAN MEMBERS:

- 1. Economic reasons for higher wages, increased benefits and shorter hours.
- 2. Job security reasons that one basic human need in the work environment to be protected against unfair arbitrary treatment.
- 3. Social environment reasons for men and women who are social beings, with having a strong need to be accepted by their peers without being discriminated against.
- 4. Recognition reasons for employees that have found that Unions offer them an opportunity for gains; for example, a worker with little education may serve on committees or even as positions of influence such as Officer or Executive Board Member of the Local Union and/or company's (CTA) influential positions such as Clerk, Supervisor or Instructor.

<u> Assistant Business Agent – Maintenance January 2021 Report</u> <u>By Marqueal L. Williams</u>

USB Cable Installation

I (Marqueal Williams) filed an Unfair Labor Practice against CTA Management, CTA took it upon themselves to implement to all our Union Members / Employees, that any mechanic can work on the Clever Device System, this new procedure did not come before Local Union 241. Local Union 241 (Marqueal Williams) ABA – Maintenance sent out an email to Cease and Desist of any Union Employees doing vendor work until Local 241 receive a copy of the Bulletin 8m-8-14-13. Management is stating that any Mechanic can do this work. This statement is not true because if the Union deems it to be Union Work, then only workers that can touch that cable would be the Employees that are Radio/Signs Certified. CTA Refuse to Send Local 241 the Memo/Bulletin before our members receives it. The Union also filed a grievance requesting that everyone who was violated be compensated financially.

COVID-19 TESTING

Due to the high number of COVID in the Maintenance Department I will be working with Action Coalition of Englewood and we will have a COVID-19 Testing Drive in March, this will be the first of many, we have many of members who get tested because CTA place a sign on the manager window stating that "Someone at you location tested positive for COVID-19", at the same time Management have the employees scared to report the names who they were around, because Management is giving everyone and you a behavior violation referral, because the General Manager is stating that You Did Not Practice Social Distancing.

Note: Management have not caught anyone not practicing Social Distancing but wants to write you up to make themselves look like there are doing their job, and caught you not practicing social distancing THIS IS WRONG. If you did not physically see me, how the hell you are going to write me up for following CDC guidelines? If you did not Physically see me not practicing social distancing do not assume, I am not.

Management Assuming that because you got tested for COVID-19 that you must have been in contact with someone or that you're having COVID SYSTEMS, but management do not understand that by placing a simple letter on a window without cleaning the facility is not protecting you or your families, the employees see that the affected area was not cleaned, Management the Employees' see that nothing was done to protect them, but management is quick to administer discipline, when they should have been quick to make sure our working environment is safe and clean. We must do better to protect ourselves, we all must wear our masks, we all must practice Social Distancing when possible, we must wear gloves and spray the Mimms Machine with Hepicide Quat II, also spray down the driver area before working on the bus, this pandemic is still in effect remember there are some great managers that will go to the limits to make sure we are all safe, we also must do our part. If a job requires Two-Man to assemble, then do the job as much as you can by yourself and then ask for the help. Remember constant testing is to protect you. I will keep you inform via' social media and email of the COVID-19 Testing Drive.

Discipline Hearings

I cannot express this enough, if you need Union Representation you MUST call the representative of your location, in the Maintenance Department we do not have set Discipline Days, and Management do not give the Union Reps a "heads up" that you are being disciplined.

Here are your rights; you have 24 hours to receive union representation from the time the manager gives you the referral. You should call your Union Representative as soon as possible, for the investigation to get started. Remember you have only 30 days to file a grievance so if you received discipline on December 30, 2020 and you file your grievance on January 30, 2021 your grievance will be processed as UNTIMELY. Go find a calendar and do the math. So, stop waiting till the last minute and file the grievance early.

Line Instructors

The Union and CTA is at talks about Line Instructors, Local Union 241 presented this as a proposal during contract negotiation back in November 2019, along with revamping our Training Instruction Department, Local 241 Maintenance Line Instructor was always an essential need for the Maintenance Department, whenever I'm doing discipline at Kedzie Garage Location at night, I see Bejoy Kappen training an employee on EMIST, Bejoy instruction hours is during the day, but Bejoy is performing the needs of the company and his co-workers, this could have been done by a Line Instructor.

We are preparing the MOU to start dialog with the Authority, President Hill expressed that this MOU will not intervein with regular contract negotiations, the original proposal will be enforced as written. The current contract proposal has the need for not only Line Instructors but also (3) three additional Senior Technical Trainers.

Electrostatic Sprayers

It has been brought to Local 241 attention that the new Electrostatic Sprayers (EMIST Machine) are breaking, this issue is being address if anyone uses a machine that has broken while in use, you must go directly to the office and report that machine, Do Not try to fix or fabricate. If a manager asks you to fix it and it seems questionable, call your Union.
