



## REPORT OF THE PRESIDENT B/A KEITH D. HILL APRIL 2022

*Below is my report for the month of April 2022, presented to the Executive Board on April 27, 2022 and the Members on May 3, 2022 during the Mass Membership Meeting.*

### FMLA (FAMILY MEDICAL LEAVE ACT):

- The **Family and Medical Leave Act of 1993 (FMLA)** is a [United States labor law](#) requiring covered employers to provide employees with job-protected, unpaid leave for qualified medical and family reasons. [1] The FMLA was a major part of [President Bill Clinton's](#) first-term domestic agenda, and he signed it into law on February 5, 1993. The FMLA is administered by the [Wage and Hour Division](#) of the [United States Department of Labor](#).
- The [Family and Medical Leave Act \(FMLA\)](#) provides certain employees with up to 12 weeks of unpaid, job-protected leave per year. It also requires that their group health benefits be maintained during the leave. FMLA is designed to help employees balance their work and family responsibilities by allowing them to take reasonable unpaid leave for themselves or certain family for medical reasons. Employees are eligible for leave if they have worked for their employer at least 12 months, at least 1,250 hours over the past 12 months, and work at a location where the company employs 50 or more employees within 75 miles. Whether an employee has worked the minimum 1,250 hours of service is determined according to FLSA principles for determining compensable hours or work.
- Over the last year, many members who are eligible for FMLA have not been following the correct procedures for calling in and reporting such absences. The failing to follow procedures regarding FMLA reporting has resulted in the CTA taking disciplinary action. Because you may be entitled to an FMLA qualifying absence, you are not automatically protected. While you may be entitled to and eligible for FMLA leave, the law is very clear. The federal FMLA regulations states

that **“An employee must comply with the employer’s usual and customary notice and procedural requirements.”** Therefore, if you want to take FMLA leave you must follow the CTA procedures, which includes calling in at the proper time, 2) notifying your manager and 3) notifying Reed Group. Simply notifying your manager that you will be off for FMLA is not enough. You must also contact Reed Group.

- If you do not have FMLA please do not attempt to take it without applying for it. To apply you must call the Reed Group and request a package. After you receive your package, you must have your doctor fill it out. All packages have a time frame to return back to Reed Group to be reviewed and determined. **Taking FMLA without having FMLA could lead to serious disciplinary actions.** When reporting FMLA please report the correct number of hours to be taken, the hours will be determined by the run you are scheduled to work that day.
- **If you fail to follow the correct procedure, there can be several consequences:**
  - The CTA may deny your request for FMLA and you may be subject to disciplinary actions for a violation of the Rules of Conduct.
  - Even if the CTA grants your request for FMLA, you still may be subject to disciplinary action for violating the Rules of Conduct by not following procedure or for a behavioral violation, depending upon the circumstances.

Local 241 is challenging a few things with the Department of Labor (DOL) because we believe the CTA is violating or misinterpreting some of the rules from the Department of Labor. Therefore, in order to protect yourself, please follow the correct procedures. If you have any questions, please contact your Local 241 representative.

**SAFETY:**

- Legislatively we had a bill in Springfield to address some of our needs, the bill had three parts to it:
  - One, was to give all agencies the right to ban a persons’ riding privileges.
  - Two, was to make sure all buses have a shield. This part of the bill passed and was earmarked for 8 million dollars. With this on top of the federal money, CTA has no excuses for all buses to not have a shield. We will keep pressuring them to get this done faster.

**SAFETY(Cont.):**

- The third part was some form of penalties from assaulting a passenger or operator. The Black, Latino and Progressive Caucus members were not in favor of this, saying it supports mass incarceration and was against sending anyone to jail. After several meetings with members from each caucus expressing how the Local thinks that position embolden criminals and, in my eye, I think it shows a lack of respect for working men and women.
- The other two parts of the bill are not dead yet and have gained the support of other agencies and unions in transportation throughout the state. We are waiting on two things to keep the fight going. We are waiting to see if and when a day in May will be called and a veto session later in the year. This union and its members must be ready to take a stand for safety. I'm waiting on a date and we'll be looking to take a few members with us to testify to the legislators on how rough it is to drive and the level of fear and disrespect we go through every day. I will keep the members updated and let's all stay ready, Local 241.

**PACE WEST:**

- We are set to meet for contract talks on the 28th of April and we are looking to move forward after this date. We are looking to secure as many dates as we can for the month of May and June.
- We also met over the pick for maintenance, the goal of the union is to protect and preserve the work and make sure we are not losing jobs.
- I also hope all part timers who wanted to become fulltime have been asked, if you have not, reach out to the union.

**PACE NORTHSORE:**

- Myself and Steward Aloy had a meeting with management of Northshore. In this meeting we talked about a few things that we feel are problems for the Brothers and Sisters of Northshore.
- We also hope that all part timers who wish to be full time jump on the opportunity. We will be coming around to make sure everyone was asked, soon.

**PACE SOUTHWEST:**

- We would like the members of Southwest to know you are not forgotten or going unheard about the incidents that take place at the 95th redline station. Please do not be afraid to keep the union abreast of any incidents you may have, your safety is a concern for all that work at the 95th redline station.
- We are also hoping that every member who wanted to be fulltime has been offered, if not reach out to the union so we can look into this. Local 241's mission of trying to make sure everyone we represent are full time is a reality and we will keep pushing and stay focus to make PACE a better work place.

**EXPEDITED AND PRE-ARBITRATION & LABOR CHARGES:**

- In the month of April Local 241 did hold expedited arbitration to address grievances. Local 241 took over (45) grievances winning (33) in some form by way of the arbitrator.
- This administration will keep addressing the grievances and keep working to reduce the amount of time members must wait to be heard.
- Labor charges in the month of April, we had two (2) cases dismissed and two (2) new cases brought against the Local.
- We also had (5) letters of complaints/charges written to the International against the Local, all were responded to and all complaints/charges were dismissed and closed as unfounded.

**PART TIMERS:**

- In the newest tentative agreement with the CTA, Local 241 reduced the part time workforce to 12%. This was a major thing for all Local 241 members with greater benefits to come in the future.
- All part timers, we would like to make sure you have all been asked and have had the opportunity to accept or reject the opportunity to become a fulltime bus operator. If you feel or think you might have a concern with this, please reach out to the union.
- We are expecting all part timers who elected to be full time in the month of April.

**MASK:**

- As a result of a court order, effective April 18, 2022, the Centers for Disease Control and Prevention's (CDC) January 29, 2021 order requiring masks on public transportation conveyances and at transportation hubs is **no longer in effect.**
- While the city continues to see low levels of transmission of COVID-19, customers and employees who wish to continue wearing masks are encouraged to do so. - If at this time you contract Covid, please make the union aware of this because we are still holding the CTA and PACE to the rules.

This is a great accomplishment because often the union is left out of these groups with no voice at the table. Well, I'm proud to say, we have a seat at the table and our voice will be heard. This allows Local 241 to make sure our work is protected and will have the opportunity to grow in the upcoming years. This is another accomplishment of this administration.

**AWARD:**



- ❖ Cases are being won with little to no lawyer involvement. This is a cost savings to the Membership, brought to you by the hard work of this administration.

### **Pension**

- ❖ I attended a Pension Personnel meeting on April 21, 2022.
- ❖ I also attended our regularly scheduled Pension Board Trustees Meeting on Thursday, April 21, 2022.
- ❖ Pension Meetings are held every 4<sup>th</sup> Thursday of the Month. The April 28, 2022 meeting will be held after our Executive Board Meeting and any updates will be report next month.
- ❖ Members, now is always a good time to make sure your beneficiary information is up to date. I can't stress enough the importance of making sure your benefits are properly allocated.



## **Education Training**



For the month of April, I was assigned to North Park garage to do discipline as well as assisting the other North, West and Southside garages, including PACE West, PACE Southwest and PACE North Shore in addition to doing various duties assigned by President Keith Hill and corresponding 1st Vice President duties.

### **5-DAY LETTERS**

Please upgrade your new address with CTA and Local 241, as soon as possible so that they/we can send out your proper information when necessary. Members are still saying that they never receive the paperwork/information. Remember that it is the member's responsibility.

### **FMLA**

We are still having a lot of problems with the members not calling the REED GROUP when taking FMLA. CTA is moving forward of trying to discharge our members. Remember you have 7-days to call the REED GROUP, when taking FMLA.

### **NEW FULL-TIME EMPLOYEES**

Congratulations to all the NEW full-timers. If you were due a uniform allotment, you should still receive them. Your benefits don't kick in until 90-days turning into full timers. Vacation time is accumulated from January 1<sup>st</sup> to December 31<sup>st</sup>, you must work 200 days to get full vacation time or it will be pro-rated.

### **PRE-ARBITRATION**

Myself and President Keith Hill presented (14) cases to CTA management, that couldn't have been won in "Regular Arbitration". After hearing the cases, CTA "Allowed" (4) jobs back and the other (10) cases will be sent back to arbitration status. This was done with no lawyer involvement or fees.

### **EXPEDITED ARBITRATION**

I attended "Expedited Arbitration" along with President Keith Hill via *ZOOM Conference Call*. We submitted (45) cases: winning (33) by way of "Allowed" or "Allowed In-Part", and (12) cases "Denied" by an arbitrator. All were done with no lawyer involvement or cost to the membership, only arbitrator fees.

### **AVAS**

Reminder, CTA is issuing violations for AVAS. Please let's do our due diligence to make management do their investigation. Also, please fill out the dispute forms on everything and you only have (14) days to file a grievance, once you're given an AVAS violation.

### **PENSION**

The pension is solvent and it has over 2 billion dollars in it.

Today April 20, 2022 I (Marcin Kotarba) joined the 2nd Vice President Tanno Muhammad in the step 2 of the Grievance process and a couple of Drug/Alcohol hearings at 567 W. Lake St. During this time I was able to see first hand how the process is done and how grievances are passed to Arbitration. I was able to participate and provide my input on the grievances that were presented to us. Even though in a lot of the cases it showed that the operator was not at fault or there was no way of avoiding the accident. The person hearing us out couldn't do anything about it because his boss wouldn't allow it. So the cases had to be pushed off to arbitration. Even though he agreed with us it still had to go to arbitration. I also noticed how CTA will use the rule book or the C.A.G. as they want, and change the interpretation of words to suit their needs. That was most prominent during an accident hearing where a cyclist who was not paying attention and had headphones on turned in-front of a bus causing an accident. CTA labeled a cracked windshield as Serious Damage. Charging the Operator with a Class 1 Accident. Where it clearly states in the V.A.G. that Serious damage is labeled as "Damage to property or Vehicles in which one of the vehicles suffered disabling damage (Towed Away from Scene).

During the Drug/Alcohol hearings in my CTA showed no remorse to the employee. Especially in one case where Concentra threatened the employee with having police called on them and labeled him as a "REFUSAL" just for questioning their procedures.

This over all was an eye opening experience. To see how the process works and steps that are needed to file a correct grievance and how step 2 conducts its hearings.

### **Judgement Calls on Road Calls**

Mechanic and Servicers, when you are on a road call for a Dead Motor, Flat Tire, Fumes, Roaches/Bed Bugs, E'-Stroke/Brakes, and you decide that the bus needs a Tow, **the judgement call is totally yours.**

Many Maintenances ask the question if Bus Operators can't drive the bus with roaches why they think we can? The answer to that question is our First priority is to the Riding Public, not to have roaches or bed bugs on the bus, not to inhale fumes, remember you can order a Dust Protection Coveralls it goes up to size 6XL. Second is the Bus Operator working space, the operator is in that seat all day, if the operator has a problem with his/her working condition another bus will be ordered. Maintenance Life or Transportation Life will not be jeopardized in order to save the Chicago Transit Authority funds. If you are one of those diehard employees that likes to save the company money and you make the judgement call to drive that flat tire back to the garage and the bus catches on fire or while driving that bad brake bus you kill a family of five, then that is the judgement call you must deal with.

When you go on a Road Call make sure you know what that road call is for, you should always bring the Company Cell Phone with you, that is located in the office, if the office does not have a phone that you can take for Road Calls, please let your Union Rep know, and we will get one for that location.

### **Things to Remember**

1. MMIS: Jobbing out for lunch and back in for lunch.
2. Leaving good notes on your work orders.
3. Check for parts order before ordering parts to make sure duplicates parts haven't been ordered.
4. Tardy/Attendance when you are at the toolbox meeting you must be dressed for work.
5. Out of Work Area: If you are going out for lunch you MUST let Management know that you are going out for lunch.
6. Electronic Device Policy: if you are on your cell phone you should be on break.

### **Pace West Pick**

Pace West had a winter pick in 2021 and there were a Mechanic Position removed from the pick, everyone at Pace West knows that when Pace Maintenance Management want to place a person of their choice on days, they won't let them pick, using the excuses that the person is in training and will not be able to pick until he finishes his training. Marqueal Williams and President Keith Hill had a

meeting with the Operation Manager of that division and the outcome of that meeting was to note at the bottom of the pick of how many actual positions that belongs on pick for hiring. Our goal is to have all the position on the pick without putting VACANT on the pick. Local 241 will defiantly advance the grievance to arbitration.

### **Pace West Contract Negotiations**

Local Union 241 is in contract negotiations with Pace West, all maintenance grievance will be addressed during these negotiations. The Union will also address all past issues and if you have any upcoming issues please reach out to Marqueal Williams or President Keith Hill 312-341-1733.
