*Below is my report for the month of June 2022, presented to the Executive Board on July 1, 2022 and the Members on July 1, 2022 during the Mass Membership Meeting.*

**NOE GARCIA-STEWARD PACE SOUTHWEST:**

- *I would like to start off my report by asking members for a moment of silence. We lost Noe Garcia on Thursday, June 9, 2022. Noe was our Steward from PACE Southwest, a true fighter no matter how big or small the situation was. Noe was a no-nonsense guy with a joker of a type grin, as I use to tell him. I'm going to miss our Brother and I know the Brothers and Sisters of PACE Southwest will too, let's keep his family in our prayers!!!*

**SAFETY:**

- Security remains one of the most important issues of this administration. The safety of all members CTA, PACE and First Transit is top on the list of this administration. The conversation about things on the bus as well as new ideas off the bus, talks and pressure about the shield that encloses the operator are very heavy and both parties agree that it is a must.
- Operators Local 241 is asking, **PLEASE do not get off the bus to confront anyone!! PLEASE stay on the bus!!**
- Local 241 has been meeting with the CTA and other agencies about safety for over two years. These meetings are sometimes held bi-weekly but definitely once a month. We are looking for the members to help with trouble spots and danger spots, please inform the Union.
- On June 26, 2022 on the Pulaski route, CTA was a victim of the city violence on our system. Although this was not a direct assault on the driver, it does have an impact on his life and how we operate throughout the city streets.
- As a result of this act of violence on the system and as we continue to perform our duties, Local 241 pushed for a meeting with all city leaders. This meeting took place June 29, 2022 at Chicago Avenue garage.
- In this meeting, we had the Mayor of the City of Chicago, Alder woman Emma Mitts (37<sup>th</sup>), CTA President Dorval Carter, CTA EVP Mr. Donald Bonds, CPD Deputy Commanders Carter and Cato, CTA head of security. Present from Local 241 was myself, FRST Toi Bowers, 1<sup>st</sup> Vice President Woodrow Eiland, ABA of Maintenance Marqueal Williams, Executive Board Members Tiant Gatewood (Supervisors/Instructors), Claudell Cain (77<sup>th</sup> Street Garage) and Kelvin Gilkey (Chicago Ave.) and Steward Michelle Townsend (74<sup>th</sup> Street Garage).

**SAFETY (cont.):**

- This meeting was kind of different from previous meetings the Local had a strong stance and needs action immediately. The city violence is making it difficult to provide services to the city. We express how we have kept our commitments to the city with no protection. We have no visible presence of police and the response time is way too long. We expressed how we often complain about things to CTA and the Control Center that are dangerous to us with nothing being done or looked at.
- During this meeting we expressed the need of police presence and rebuilding the relationship between operators and the police. We had a lot of positive things come from this meeting and I'm looking forward to the outcome. One thing that I'm excited about is the established monthly meeting at each location, so the members can let CPD know where the help is needed.
- I would like to thank the members of Chicago Avenue Garage for engaging and expressing their safety concerns to Mayor Lori Lightfoot, President Dorval Carter and the Chicago Police Department. Other locations, please be on the lookout for rap sessions in the upcoming weeks to express your safety concerns that deal with your location.

**AFL-CIO CONVENTION:**

- The AFL-CIO is the largest Union organization in the United States. It is made up with a body of several hundred unions from all over the world from actors, nurses, ship yards to the NFL players. With an attendance of over 4,000 including a few hundred from overseas. The energy in the room was filled with love, professionalism and unity.
- As delegates, we elected the first woman Liz Shuler as the President of the AFL-CIO in history along with the elevation of an African American Fred Redmond (from the south side of Chicago) to the second highest position as Secretary-Treasurer. This was Historic and I was proud to cast my vote. Our International President was elected as a new Vice President along with 54 other Vice Presidents.
- Resolutions were respectfully debated on dealing with Safety, Gun control, fighting to create more jobs and fighting to get back more jobs from overseas. All were unanimously approved!
- We heard from Secretary of Labor, Marty Walsh on organizing, educating, forming unions and assuring us all that the Labor movement is his priority. It is quite evident that the Labor movement in the white house and around the country is stronger than it has ever been. We are at the table with our voice, input and part of the decision making.

**AFL-CIO CONVENTION (Cont.):**

- President Biden delivered a strong speech of love and tremendous support along with billions of dollars allocated for Transportation. An allocation of funds that has never been done before for transportation.
- Many resolutions were reviewed and unanimously approved by the AFL-CIO voting delegates. Resolutions addressed safety, healthcare, apprenticeship programs, diversity and other subjects all empowering the future of Unions. This was another achievement for Local 241 and an honor to represent our Union at this convention and be a voting delegate as we move the U.S forward in Labor.
- Also, in the month of June I had the extreme honor of sitting with our Vice President Kamala Harris and discussing transit as a whole and safety of transit in Chicago and the United States. I was one of 12 Labor Leaders to meet with her as the Vice President pledge the support of the White House for all of Labor. I questioned the agenda of autonomous buses that the White House are expanding the studies on. I expressed how this hurt the industry and the safety of this in mass and rural transit. The meeting conversation was quickly taken over by the supreme court's ruling on the Roe versus Wade ruling. Overall, I was truly honored to be selected and to participate in this event.

**EXPEDITED AND PRE-ARBITRATION & LABOR CHARGES:**

- In the Month of June Local 241 held *Expedited Arbitration* to address grievances. Local 241 addressed (75) grievances for the members of Local 241; winning (59) by way of an arbitrator's decision.
- Pre-Arb was held in the month of June, we took over (10) cases winning (7), please welcome our Brothers and Sisters back to work.
- **This administration will keep addressing the grievances and keep working to reduce the amount of time members must wait to be heard and a final decision.**
- Labor charges in the month of June: We had two (2) cases dismissed and one (1) new case brought against the Local.
- We also had (1) letter of complaints/charges written to the international office, against the Local. All were responded to and all complaints/charges were dismissed and closed as unfounded.

#### #4 Cottage Grove and the 6 Jeffery

- In the month of June, myself and First Vice President, Woodrow Eiland met with planning. In this meeting CTA expressed to us how Chicago State University was reclaiming the bus terminal and moving CTA out.
- The Local was ok with the #3 king drive, but had major concerns about the #4 Cottage Grove. The suggested terminal would be 95th and Cottage Grove, placing us with another porta potty as a restroom along with another gas station that may let us in or not. We could not understand this and fought against it along with the members of 77<sup>th</sup>.
- We thank all who took the time to fill out a support letters for the Union, we received (427) yes votes and (0) no votes, on the fight for change. The requested two different terminals less than two miles between both either take the #4 to 95th and the redline or to the 103rd street garage both are owned by CTA, both have a bathroom and other amenities to help the operators. I will keep all posted on the results.
- #6 Jeffery, we also see this as an opportunity to push CTA to change the relief location for the #6. We have been fighting this issue since October of 2017, I want to thank the (238) Brothers and Sisters, who all said yes. We will keep everyone posted before the next pick.

#### VRD's:

- Since 2011 the members who have not taking their VRD's have lost them. Employees who are eligible to pick three (3) or more complete weeks of vacation will be allowed to select one (1) week, five (5) days, of non-consecutive vacation days. Employees who are eligible for four (4) or more complete weeks of vacation will be allowed to select two (2) weeks, ten (10) days, of non-consecutive vacation days, hereinafter referred to as **vacation random days ("VRDs")**. Such days will not be made cumulative from year to year. This year Local 241 negotiated a MOU (memorandum of understanding) to pay the members who could not use their VRD'S. Members will be paid out up to 5 VRD'S for the previous vacation. Local 241 encourage all members to use their days in the future.

#### PACE WEST CONTRACT NEGOTIATIONS:

Due to COVID-19, the contract meeting was cancelled this month. But we had (3) sub-committees that met and we are looking forward to bringing the results to the negotiating table. As of today, we have (11) TA's (Tentative Agreements) with over 50 items still open for negotiations at the table. We have two dates in July 2022, we will keep you updated.

## **THINGS YOU NEED TO KNOW**



### **ATU International Dues Increase**


Under Section 18 of the CONSTITUTION AND GENERAL LAWS, the per capita tax and minimum dues rate for all active members must be adjusted each July based upon the annual percentage increase in the Consumer Price Index (CPI-W, 1982-84=100) published by the U.S Department of Labor. Dues notices regarding the increase has been posted. The new monthly Dues for CTA will be \$75.00.

For the month of June, I was assigned to assist the North Park garage to do the discipline as well as assisting the other north, west and south side garages, including PACE West, PACE Northshore and Pace Southwest as well as doing various duties assigned by President Keith Hill and corresponding with other 1<sup>st</sup> Vice President duties.

### **SAFETY FOR THE OPERATORS**

**It's really getting crazy in Chicago and dangerous for all of the bus operators. For your own safety, please follow the S.O.P's (Standard Operating Procedures) with the passengers. Please, have as little as possible conversation with them. We lay our lives on the line with CTA and PACE. Everyday we come to work with not enough security and a bunch of promises that we are getting from CTA and PACE. The Officers and the Executive Board/Stewards are doing everything in our legal power to put pressure on them.**

**If you feel like something is wrong, please press the silent alarm or call by phone when it is safe to do so.**

Something has to give; CTA and PACE has to understand that we are people not robots!

### AVAS

We are still getting a lot of calls about AVAS. If you don't understand, please get in touch with your Union Representatives or call the Union office to talk to an Officer, please. **FILL OUT YOUR DISPUTE FORMS** (see attachment).

### FMLA

Members are still not calling REED Group when taking FMLA. *Just know that CTA in turn is putting members up for "Discharge" or "Last Chance Agreements" with 29 days off, NO PAY!*

### 5-DAY LETTERS

Members, if CTA sends you a 5-day letter, please call your "Business Manager" or "Senior Manager" at your garage A.S.A.P. If you fail to do so you will be **Administratively Separated**.

***Please update your phone number, address, etc. with CTA and the Union, where ever there is a change in your information.***

### IOD-Area 605/SICKBOOK-AREA 605

There is big difference between **IOD-Area 605** and **Sickbook-Area 605**. Members, please understand that when you go out on an approved **IOD-Area 605**, from the company; when you come back you will be made whole, not losing anything or being replaced by another member. When you are out on **Sickbook-Area 605**, you can't lose any seniority, but **can be sent** to another location (where ever CTA is short manpower).

**REMEMBER: THAT A.P. 1010 IS ONLY FOR SICKBOOK-AREA 605 ONLY AND NOT FOR IOD-AREA 605!!!!!!!**

### EXPEDITED ARBITRATION

I attended "Expedited Arbitration" along with President Keith Hill, FRST Toi Bowers and Executive Board Member Tiant Gatewood via ZOOM conference call. At Expedited Arbitration we submitted 75-cases winning 59-cases by way of being

***“Allowed”*** or ***“Allowed In Part”*** and 16-cases were ***“Denied”*** by an arbitrator. All were done with no lawyer involvement; the only cost was arbitrator fees.

## **AVAS-BLIS Revised Order Summary**

- Bus Operators must sign and complete the "Operator's AVAS Dispute Form" and turn in to the Transportation Manager no later than four (4) days after the third (3<sup>rd</sup>) and final posting for the relevant bi-monthly period.
- Failure to submit the "Operator's AVAS Dispute Form" within the four (4) day period shall be taken as the bus operator's agreement of the AVAS-BLIS data that is posted.
- Local 241 may grieve the level of progressive discipline.
- Local 241 must be provided all information that the CTA relied on for disciplinary action including AVAS-BLIS data and reports and any other relevant CTA and Bus Operator reports.
- CTA will notify the Recording Secretary of Local 241 of the disciplinary action by email.
- Local 241 shall email the CTA a completed AVAS-BLIS Grievance form within fourteen (14) days if they want to meet with CTA about the disciplinary action.
- The CTA Vice-President of Bus Operations or his designee will meet with Local 241 Recording Secretary or his designee at least once a month about the disciplinary action. If they are unable to agree on the discipline, Local 241 has the right to protest the discipline through the expedited arbitration procedure within twenty-one (21) days of this meeting.
- If Local 241 does not email the CTA about the disciplinary action, the discipline shall be deemed conclusively for just cause.

- ❖ 5 members EAP/ SAP



**REQUESTING A VRD DAY:**

When applying for a VRD day you must FIRST give a (3) three-day Prior Notice, except where permission is granted by the foreman, SECOND you must check with your Time Clerk to see if the day's you're requesting are available, THIRD you must submit the form to your Shift Manager he must answer your request within 24 hours of applying. All this is contractual MANAGEMENT has (3) days to adjust their man-power if the days are open. Management has to now do their JOB and Manage with the limited resources we all are working with.

**THINGS TO REMEMBER:**

1. MMIS: Jobbing out for lunch and back in for lunch.
2. Leaving good notes on your work orders.
3. Check for parts order before ordering parts to make sure duplicates parts haven't been ordered.
4. Tardy/Attendance when you are at the toolbox meeting you must be dressed for work.
5. Out of Work Area: If you are going out for lunch you MUST let Management know that you are going out for lunch.
6. Electronic Device Policy: if you are on your cell phone you should be on break.
7. This is not an issue in the Maintenance Department but remember to call Reed-Group when you're calling off FMLA, then call the garage with your claim number.


