

REPORT OF THE PRESIDENT B/A KEITH D. HILL JUNE 2021

Below is my report for the month of June 2021, presented to the Executive Board on July 2, 2021 and the Members on July 6, 2021 during the Mass Membership Meeting.

CONTRACT:

- The month of June will start three (3) rounds of contract talk for Local 241.
 - Local 241 who has been in negotiations with the Chicago Transit Authority.
 - PACE West and First Transit both have agreed to start negotiations and given dates to start talks.
- CTA in the month of June, held two meetings which resulted in CTA giving us gut wrenching proposals. We found this to be very insulting and undermining the work we do and have done, especially over the last year. The Union and CTA are scheduled to meet 32 times from July 15 to August 28, 2021. This Administration stand firm on **“we have nothing to lose or give up”** and will hold our ground on that.
- PACE West, please be on the lookout for the contract proposals and take your time and voice your concerns. We will list the proposals and give it back to the members before we exchange them with PACE.
- First Transit should’ve already received their contract proposals and we are looking to receive them back to list in order of importance according to the members.

The Goal of the Union is to present each with the best agreement and to enhance the quality of life of all members.

RHCT BILL 1428:

Both Locals had great success in Springfield with our first test under the new leadership in Springfield. HB1428 Amends the Miscellaneous Collateral Provisions Article of the Illinois Pension Code. Provides that effective January 1, 2022, all employees of the Chicago Transit Authority shall contribute to the Retiree Health Care Trust in an amount not less than 1% (instead of 3%) of

compensation. The Bill was sent to the Governor on June 29, 2021 and is expected to signed after the 4th of July holiday.

This is just the start of the work we have to do in Springfield. As we will keep working to see more of our paycheck and the money we earn, work with us.

REED GROUP:

- The Local needs the members to let us know when they are going for a second or a third opinion. CTA and the REED group are doing a few things we need to watch. Members are traveling more than 30 miles to go see the doctor.
- The biggest thing is when you are attending the appointments for second and third opinions on your off days. The Local is not in support of them making you go on your off days. This action I believe is a retaliatory action against our membership. I think the CTA should pay members time and a half for this action. A class action is being filed to recover and protect the members. The Local is also aware that no information from the second opinion is being shared with the members that are being sent to a third opinion.
- The law gives them the right to send a member for a second or third opinion, we just have questions on how things are done.
- As we ask the members to help us identify members who we think are harmed, we also ask that your bear with us as we address this.
- Please, also remember, when taking FMLA you must report it to the CTA and the REED group. You must also report the correct hours taken; this is a crazy write up so let's report the correct usage of FMLA.
- Members who are still having problems with claims and response time from the REED group, can you keep reaching out to Sister Bowers so she can help you out with the process. If the REED Group is denying you because you are part time or newly turned over reach out to us to assist you with this.

EXPEDITED AND PRE-ARBITRATION:

- The Local held Expedited Arbitration with the CTA addressing (75) cases (grievances). Local 241 won (63) in some form by way of the arbitrator. The Local also lost (12) by way of the arbitrator. If you received a letter from the Union stating you have won your grievance and the discipline needs to be removed, please take your Union representative into the managers' office with you to assure the violation is removed. We are coming across grievances that have been won but the discipline has not been removed for the members' record. I have to commend the board for addressing issues and stop a lot of things at the garage level.

EXPEDITED AND PRE-ARBITRATION (CONT.):

- When this administration began, we had open grievances going as far back as 2007. With the hard work of the First and Second Vice Presidents and myself with Pre-Arb, Expedited and Second Step, we can now say we are up to and halfway done with 2015 all while addressing some current grievances. We still have some discharges and contractual grievances waiting to go to arbitration, but the numbers are way low for those years.

The Union is waiting for a Pre-Arb date in July to address discharges. We have also received several dismissals from the Labor Board on seven cases that were pending against the Local.

JOB FAIR:

Local 241 and CTA teamed up to give our family and friends a chance to work with us. On June 30th, we held our first job fair with 667 signed up to participate, on the call we actually had 227 to participate. If you had someone in mind please be on the lookout for the event. We might have our differences with the job, but we all know someone who can do this and earn a good living. This is also a form to strengthen our membership, so please look out for the next one and let's beat these numbers.

SUPERVISORS:

Local 241 has been in talks about the clerk job one and two. There has not been any conclusion from the meeting thus far. The Union believes that all jobs are important and that the supervisors are understaffed and need more people to actually assist all the calls. The Union believes no job should be backfilled. We will keep all posted as the meeting moves forward.

CITY OPENING:

Although the city has fully opened, we must not let our guard down. The city is open and the virus is still going and active, please remember to wear your mask while driving, don't trust any passengers. The Local is asking PACE and the City to bring some normalcy back to the garage level just because the state and city are open, we are still being locked out of some places.

AVAS STARTING UP:

June 20, 2021, the CTA started back using the AVAS system to monitor buses and the terminal activity. We must get back in the practice of this procedure. As a Union and members, we must remember to dispute and record our activity and delays, we must get back in the practice of filling out dispute forms and watching all time lines and postings, the Union will start conducting Rap Sessions to educate the members on this process. I also have attached a copy of the award with

my report to guide members on how to protect themselves during this time. The most important thing to remember, if you are filing a grievance on the AVAS, it must be done within 14 days and on a **AVAS dispute form, not a regular grievance form**, if not the award clearly states it is denied and withdrawn. So, let's work together to keep all records clean.

CDL:

- **All CDL facilities are open, the license extension is not for CDL holders** so please don't get caught without your CDL. Please remember you can renew your CDL 364 days before they expire. By doing this you can actually give yourself five years before your next renewal.
- If your license is disqualified and you are pass your 180-day period please keep in contact with Local 241, we would like to make sure you have time to address your issues or things you may need to do to bring your CDL in good standing.

PACE:

- **Pace West:** I sat in on a couple of hearings this month and worked with Chris and Jack to resolve a few things dealing with pay and time off recovery. We are working on a labor management day soon to resolve a few grievances.
- **Pace Northshore:** We will be visiting in the month of July starting with a labor meeting on the 8th
- **Pace Southwest:** I visited a few times in the month of June with Board Member Caesarie and Steward Noe Garcia. We will be having a labor management meeting in the upcoming weeks.

All of the Pace locations will be receiving a Wellness Benefit Bonus starting in July.

UNIFORMS:

Please remember, CTA will have a new uniform vendor starting in August by the name of Silkscreen. They will have three locations for us to use and should be well stocked. Please let the Union know if your voucher is not transferred over with the change. The Union is not expecting any problems but will be ready if they come about.

BILLS

All Bills are paid and current. The Per Capita Tax (or taxes paid by Local 241 to the ATU International in order to keep our Local in “good standing,”) is paid and up to date as reflected in my treasury reports.

I have provided the Executive Board and the Membership access to Local 241’s treasury reports, which includes the Profit loss, Balance Sheets, Payroll Journal and Timesheets. They are always present and available for viewing at all Executive Board and Mass Membership Meetings.

I have also issued Executive Board Minutes dated May 26, 2021 and Mass Membership Meeting Minutes dated June 1, 2021.

Local 241 has also renewed its bond. This is an important insurance mechanism that safeguards the Locals financial stability.

Open Grievances

- ❖ The number of open grievances for the month of June 2021 is 1784.
- ❖ This Administration, under the leadership of President Hill continues to return our brothers and sisters to work after being unjustly harmed by the Authority.
- ❖ Cases are being won with little to no lawyer involvement. This is a cost savings to the Membership.

- ❖ Local 241 is still resolving grievances. This office demands that pay issues effecting hundreds of our members be rectified immediately. In some cases, Members are eligible for quick pays.

COVID – 19

On June 11, 2021, Chicago entered into its Phase 5 reopening stage. This does not mean the Pandemic is over. Local 241 will continue to follow all safety measures. This will help keep all of us safe. I would like to thank Local 241 for stepping up and following the procedures that have been put in place at every phase.

- ❖ Local 241 has an open-door policy. Appointments for the more complicated issues is still encouraged. It also ensures that the officers will be able to help you more efficiently. Not only do we maintain an open-door policy, President Hill continues to use Zoom, social media and Email to keep members updated.
- ❖ The Warden also keeps our properties supplied with Officers reports and our Union Boards updated with important announcements. Please continue to check the Union Board at your location and watch out for our monthly reports. Our office staff also emails the Membership monthly reports.
- ❖ If you would like to get on the email list, please contact the Local 241 office at the number listed on the front of my report.

No PPP Loan for Local 241

As the Financial Recording Secretary, I can say that the State of Local 241's Finances is strong. This Union has been living within our means and meeting our monthly obligations. Therefore, the answer to the question some of our members have been asking about whether or not Local 241 got a PPP Loan or not is NO! **NO PPP LOANS!!!**

Pension

- ❖ I attended our regularly scheduled Pension Board Trustees Meeting on Thursday March 24th, 2021. Pension Meetings are held every 4th Thursday of the Month.
- ❖ Remember members, now is a good time to make sure that you update your beneficiary information. I can't stress enough the importance of making sure your benefits are properly allocated.
- ❖ Pension payroll audit is underway. When the results of the audit are complete, I will pass the information on to the membership.

Contract Negotiations

Contract negotiations are in progress between CTA and both Locals 241 and 308. I attended two (2) contract negotiations meetings. They were held on June 14th and June 25th, 2021. Future dates are being established as we work toward improving our wages and working

conditions. Let's continue to perform our jobs at the highest level of skill and integrity.

ATU INTERNATIONAL DUES INCREASE

Under Section 18 of the CONSTITUTION AND GENERAL LAWS, the per capita tax and minimum dues rate for all active members must be adjusted each July based upon the annual percentage increase in the Consumer Price Index (CPI-W, 1982-84=100) published by the U.S Department of Labor. Local 241 dues increase will be **\$1.00** per month. I have included the dues increase notice from the International as a part of my report further explaining the dues increase.

ATU International Training

On June 10, 2021, I attended training in the ATU United States Legislative Conference. We also covered the C.O.P.E fund. All members are encouraged to donate to the C.O.P.E. If you would like to donate, please contact your union reps, officers or call the Local Union office.

Member Arrears

Local 241 is aware that some of our members have been off for an extended period of time. It is possible that these Members may be in the arrears on their union dues. Arrears notices have been posted, letting you know that Arrears will come out the pay periods of July

21, 2021 and July 28,2021. Please check the Union Board at your location.



MEMORANDUM

TO: All Local Union Financial Secretaries

SUBJECT: July 1, 2021, Increase in Minimum Dues and Per Capita Tax

Under **Section 18** of the **CONSTITUTION AND GENERAL LAWS**, the per capita tax and minimum dues rate for all active members must be adjusted each July based upon the annual percentage increase in the Consumer Price Index (CPI-W, 1982-84=100) published by the U.S. Department of Labor.

Per Capita Tax (Effective July 1, 2021)

Beginning July 1, 2021, the monthly per capita tax for all active members (including members-at-large) is due to be increased to \$16.65 from \$16.40, based upon the percentage change (1.4490%) in the Consumer Price Index for the period between December 2019 and December 2020. ***Beginning July 1, 2021, the monthly per capita tax for those units who have been granted a reduced per capita shall be \$13.10.***

Minimum Local Union Dues (Effective July 1, 2021)

The current minimum dues rate (\$62.30) must also be adjusted, effective July 1, 2021, based upon the same percentage increase in the Consumer Price Index (2.3147%), by \$1.40. The specific amount by which your local union will be required to increase its dues will depend upon the actual dues level of your local union, as follows:

- (1) Local unions whose dues for active members as of July 1, 2019, were less than the minimum dues rate of \$60.55 must increase the dues of active members by \$2.00 (plus the \$.35 increase in per capita tax) effective July 1, 2020. The resulting new rate shall not, however, exceed the newly established combined total of \$62.30 (\$60.55 + \$1.40 + \$.35).

- (2) Local unions whose actual dues for active members on July 1, 2019, equaled or exceeded the minimum dues rate of \$60.55 shall increase their actual dues for active members by \$1.75 (representing the \$.35 increase in per capita tax plus the additional \$1.40 increase in the minimum local union dues).

For organizing purposes or in other circumstances, any local union may apply to the General Executive Board, under the provisions of Section 18.3 of the Constitution, for permission to retain a lower dues and/or per capita structure than would otherwise be required to be charged by the local under the constitutional adjustment formulas. All chargeable increases in per capita tax must, however, be collected by each local union.

Enclosed you will find a worksheet that will assist you in the calculation of your local's minimum dues effective July 1, 2021.

For the month of June, I was assigned to North Park garage to assist with discipline hearings and as well as assisting the other northside, westside and southside garages by President Keith Hill and corresponding with 1st Vice President's duties.

NEW HIRES:

Welcome to all the "New Hires". CTA is getting them in at record numbers. Please be aware of your probation period and requirements which is 5 months and congratulations.

PICK:

I attended all of the garage run picks multiple times through out the pick. The run pick was ran very smooth. I commend all of our Executive Board Members/Stewards for a job well done.

CONTRACT:

I attended two "Contract Negotiation" meetings along with the other Officers. In my opinion, I think that CTA is trying to string the Unions along, but we're hoping for the best and we are prepared for anything that they throw at our team!

SUPERVISORS:

B.S.M. (Bus Service Management) is trying to take over the Supervisor Clerk positions, but the Union stands strong on seniority. We are in talks about getting the rest of the training for the qualified Supervisors.

PAY ISSUES:

The Union Office is receiving a lot of calls about getting their proper pay. Remember, along as you submit your documentation on time and if it is over \$200.00, they must give you a "Quick Pay", it is contractual. Please get in contact with the Union Reps **A.S.A.P.** about it.

CTA ISSUES:

We are still waiting on CTA to open for full business, because our members still have a lot of issues and they can't reach any departments. CTA is still operating at 25% at headquarters and we are driving buses at 100%.

AVAS:

Remember that AVAS monitoring went back into effect June 20, 2021. Please be aware of the terminal procedures, and pullout the terminal on time. If you have any issues, please call Control to cover yourself.

CLASS ACTION:

I wrote 2 "Class Action" grievances: One on FMLA, about disparity of treatment to the members. The other one on the Instructors not getting paid mileage, when sent to other garages they didn't pick-Article 4.5 in the contract. I'm waiting for a response on both grievances.

EXPEDITED ARBITRATION:

We are still via phone call or ZOOM conference call. We had 75 cases, winning 63 by way of *Allowed or Allowed In Part* and losing 12 cases by way of the arbitrator with no lawyer involvement.

PENSION:

The Pension is solvent. There is 2 billion 43 million in it, it's really doing great.

CTA/ LOCAL 241 VIRTUAL JOB FAIR:

CTA and Local 241 had a virtual Job Fair, June 30, 2021 via ZOOM. 650 people signed up for it and over 280 were on the call. I would like to thank President Hill for asking CTA for this and we're looking forward to the in-person Job Fair.

June 2021 Report

I would like to start by saying, Peace and Blessings to Local 241 members; I hope you and your families are in good health and in the best of spirits.

As the 2nd Vice President, I have the responsibilities to represent the Local and its members assigned by the President.

United We Can Solve Our Problems and Divided We Have Nothing!

EXPEDITED ARBITRATION:

On July 24, 2021, President Keith Hill, 1st Vice President Woodrow Eiland and myself 2nd VP Tanno Muhammad met with CTA for Expedited Arbitration. We took 75 cases and won 63 in some form, either *Allowed or Allowed In Part* with no cost to the membership and most of our members will be receiving a payout.

STEP 2 HEARINGS:

I attended Step 2 grievance hearings on June 9th, 18th and 30th, 2021. I also had the pleasure of taking Kedzie Garage Union Steward Rashida Tramble with me, to show her the ropes. (See attachment)

GARAGE VISITS:

I visited 77th Street, 103rd Street, 74th Street, North Park, Chicago Avenue, Kedzie and Forest Glen garages. I assisted with several discipline hearings, discharges, accident cases, writing grievances and withdrawing grievances. I also answered any questions or concerns that our members brought forth.

SAFETY:

We are still working and meeting at CTA Headquarters with the Safety Committee. The purpose of these meetings was to point out and locate **HOTSPOTS**, relief **TROUBLE SPOTS**, **PROBLEM ROUTES** and any **SAFETY** issues that our members have made concerns about. We are planning future meetings and I would like for ALL MEMBERS to participate.

ELECTRONIC DEVICES:

We are still having members getting caught on electronic devices (cellular phones and smart watches). CTA will view the hard drive 10 minutes before and 10 minutes after. There was other topics such as uses -v- displays on cellular phones. This practice is extremely dangerous as your eyes are on the device instead of on the road. This safety practice for our members and customers is **PARAMOUNT** and all safety rules must be followed. **DISTRACTED DRIVING IS UNSAFE!**

DRUG HEARINGS:

I attended 6 drug hearings:

- ✓ 1-Shy Bladder
Shy Bladder is also called “Paruresis” that is a type of condition/phobia, where a person is afraid to use the bathroom when others are nearby). It is one of the common anxiety disorders in the United States. 17 to 20 million people suffer from shy bladder syndrome also know as Paruresis. It is very important that your doctor explains your condition to the MRO (Medical Review Officer).
- ✓ 4- Members entered into SAP (Substance Abuse Program) for positive specimen of THC-Marijuana from Random Drug Test that can be given at any time before, between and also after work.
- ✓ 1- Member resigned.

Anytime your out of work 60 or more days and in Area 605, when you return to duty you will be drug tested. The stories remain the same over and over: “I went to a party and ate something”. Please Local 241 members be mindful and watchful of what you are putting in your mouth, it just might be laced with THC (tetrahydrocannabinol).

PENSION MEETING:

This meeting was held Thursday, June 24, 2021.

The Pension Fund: Over 2 billion dollars with the membership contributed 13.324% to the plan.

HCTrust: Over 900 billion dollars, 149% funded by members that are paying 3%. On January 1, 2022, the members will gain 2% on their pay check because the HCTrust will drop to 1%.

CONTRACT:

On June 25, 2021, I also attended a Zoom Contract Negotiation meeting.

My name is Marqueal L. Williams and this report shall reflect the events of June 2021. Per the Bi-Laws Section 6(b) The Assistant Business Agent - Maintenance shall have the responsibility for representing the Local Union and its member in the Maintenance Department of the CTA, and PACE and First Transit.

A/C In The Garages:

As of July 1, 2021, the A/C for the Lunch Rooms at all garage is working, if you have any issues at your location, you should contact your Union Steward at the location, if you steward is unavailable, please call Marqueal Williams (312) 888-6364, for clarification when I say all air is working in the lunch rooms that is including the portables air conditioning units that we have installed as well.

Excessive Heat Awareness and Safety:

It is now officially summer, while temperatures have been in the 90's and soon will be approaching the 100's. This is the time to be aware, it may seem that you're not in danger of a heat stroke but excessive heat can lead to serious illness and can lead to death.

Local Union 241 leadership President Keith Hill, Marqueal Williams Tim Westhoff and John Mangan has made several provisions in the garage to ensure our members safety.

1. Stay Hydrated, if you feel that you need water it will be available in the Manager Office, if your lunch room has a refrigerator water will be available there as well, also each location should have a memo stating where water is available, if not please contact your Steward at that location.
2. More fans will be allocated to all locations on the garage floor, also in the inside garages we are making the attempt to have at least two fans at the Pumps. Fans should not be chained down and should be able to be used for everyone.
3. Educate yourself and check the weather forecast before coming to work, if temperatures hit above 85 degrees and heat index hit 90 degrees and above you have several rights, that your Union Leadership have made the company aware of, such as Break Buses and Lunch Room breaks, if you need extra time to cool off just inform any manager on duty that you will be at that location, no one should be denied of a Cool Down Break.
4. If you need Medical Attention especially during a heat wave, call 911, at the same time try yelling for a co-worker. You have limited time if you are having a heat stroke make the best of it.

If for any reasons that Management denies you Medical Attention call Marqueal Williams (312) 888-6364 at the time of the request for Medical. I have personally seen when I was a worker on the garage floor Management Denied Medical Attention because they did not want to do the paperwork.

Management Bullying!

On June 8, 2021 President Hill, Marqueal Williams along with Maintenance Northside Rep. Tim Westhoff and Steward Eddie Humphrey had a fire drill at Forest Glen. We took a stance at the Forest Glen Garage not to have Management disrespect our Membership.

Weingarten Rights; I request Union Representative present on my behalf. Management is not your friend, I can't express the enough, you want to complain about a manager talking to you crazy but scared to write a Report to Manager on that Manager. If you have an isolated incident and feel that you been disrespected, that's because you have been disrespected. Stand up for your rights CALL THE UNION. If you let them get away with it, you're making it harder for the next person.

Management intimidation is at an all-time high, and the Woman Managers/Coordinators are more disrespectful than the Male Managers, again that's when the union need to be informed, not at you discipline hearing or discharge hearing, like I wrote in my last month report now you gain the courage and want to speak up on your exit out of the company. When Management is terrorizing members, you must do a report to manager to start the paper trail.

On June 11, 2021 President Keith Hill and Marqueal Williams addressed this issue at our Labor Management Meeting, and the outcome from that meeting is when ANY Manager becomes belligerent, tyrant, or just Disrespectful at that time call Marqueal Williams during the incident and it will be investigated personally by the Mechanical Officer of Bus Maintenance, this will be a collective effort to resolve any harassments.

Bus Servicer Apprentices Working Holidays:


Every HOLIDAY we have to get into an engagement with CTA on forcing the Bus Servicers Apprentices to Mandatorily work the Holidays. For the Forth of July Holiday that is celebrated on July 5, 2021 Bus Servicer do not Mandatorily have to work that day, if they want to come to work in order not to have a short check, they do have the opportunity to work.

This is the new process; the employee must request the day be completing a time off request form. Any employee electing to take the holiday off, will not be paid for that day.

Local 241 has start the process of arrangements for beginning bargaining, President Keith Hill and Marqueal Williams have passed out the Contract Proposals to the Membership of First Transit. If not, I take it that Local 241 did an outstanding job last contract negotiations and there are no complaints except for cost-of-living wages
