



REPORT OF THE PRESIDENT B/A KEITH D. HILL JUNE 2020

Below is my report for the month of June 2020, presented to the Executive Board for the Zoom Executive Board Meeting on July 10, 2020.

FRONT DOOR

- In the month of June, passengers started using the front doors for both CTA and Pace.
- ➤ PACE talks have begun about new ideas. We have to keep the operators safe as we perform our job, some are similar to the changes we have asked of the CTA. I will keep all PACE reps abreast of any updates as well as ask for help on future projects moving forward.
- > The CTA has agreed to move the standee line back behind the driver and keep the seat blocked off behind the driver as a form on protection with space. The entire fleet of buses should be done by the first week of August. If we all work together, we can retool our ridership with some of the new changes that have been implemented to help us.
- There should be a message that we can play over the P.A. system to ask passengers to exit thru the backdoor if they can.
- Both agencies have a list of PPEs that will be available for us to use to protect ourselves as we work, I will address this later in my report.
- Agreeing to open the front door was not an easy call but after riding several routes I think it was best and it would relieve some of the stress we were facing and concerns that we had about ridership.

PPE

- ➤ Both the CTA and PACE have agreed to keep the membership supplied with the equipment of PPE that will offer some relief and safety as we preform our jobs.
- ➤ PACE'S list is different and is still being worked on, I will forward to the members when it is complete. The CTA list will follow and if any member has any ideas from the CTA or PACE please email or call us with it so we can work on it.

PPE (Cont.)

- The CTA- the spray and paper towels are left on the bus for us to clean behind each other as we make our reliefs. We are having a major problem with this because the items are being taken by members, which leaves others with nothing to clean their bus when they make a relief. I'm trying to get the CTA to offer the cans to the operators who would like them, not to place them back on the bus but to allow us to sign them out from a manager and when that can is empty return it back to the manager for a new one.
- I have also asked the CTA a few things to help us when we have reached our passenger load that are being looked into.

Below is the list of PPE's that is available to the members:

- Bottled Water is available at your work locations daily.
- Individual Gloves are available at your work locations daily.
- Individual Hand Sanitizer bottles were issued to employees initially. If you need to refill this item, larger bottles are available at each location as needed.
- Foamed Cleaner and Paper Towels are available daily.
- Safety Glasses are available upon request.
- Safety Goggles are available upon request.
- Face Coverings were issued to employees and are available upon request.
- Face Shields are available upon request.

Employees may contact their Manager, if they have any questions about these items.

CONTRACT

- We are looking to resume contract talks in the month of August.
- As a membership, I think we need to add new contract proposals to the table to enhance our quality of life. The pandemic should have every operator looking at some things differently with the job and I'm looking for your input and discussion about this.
- Also, we have to look at how long or how short and the economic environment we might be facing as we sit at the table. This administration and membership have nothing else to give or nothing we can lose at the contract table.

BBS BENEFIT SOLUTIONS

- ➤ Both Local 241 and 308 have agreed to a new disability insurance carrier for our membership. Local 241, both CTA and Pace will have the benefit of signing up at multiple locations. One of the challenges with PACE is the payroll deduction, so Pace will be allowed to sign up by way of the credit union.
- ➢ BBS will be accepting our members regardless of preexisting conditions as long as you are working during the time of enrollment. BBS will not require any approval from CTA or PACE to obtain benefits.
- I'm excited to bring this membership a true benefit that will have them not worrying about finances during their time of healing. So please be on the lookout for dates and times and remember you can start signing up as early as JULY 15, 2020.
- If you have AFLAC you can maintain your payroll deduction and keep them if you like. The goal was to find better, not to hurt anyone's choice. Those with AFLAC can still pay by payroll, your plan will not be interfered with. Thank you for working with us as we have found something to better our membership.

PACE WEST AND PACE SOUTHWEST

- All PACE locations we will start to move on with some type of normalcy by getting back to our labor management meetings and moving forward with some cases we were trying to resolve before the pandemic.
- ➤ I visited both locations during the month of June, to assist with hearings. I would like to ask the members at all PACE locations to be on the lookout for actions that we will need the members' help with such as emails and letter campaigns. Let's work together to achieve our objective and be on the lookout for bulletins.

OFFICE AND MEETING

- As we move forward in this pandemic, changes must be made in the office for us to hold meetings.
- We as a union still are required to follow the CDC federal, state as well as the city guidelines, this is for the protection of everyone.

OFFICE MEETING (cont.)

- I would like to start back holding Mass Membership meetings. As we prepare to do this, there will be things we have to do to prepare. The city has a rule that we can only hold 25% of what our space allows so it will be a number requirement for all meetings and we cannot exceed. The room must be wiped down after every meeting (chairs and tables) everyone must wear a mask.
- The city is still suggesting no large gatherings, so be on the lookout as we make changes to bring our Union back to some type of normalcy.

1. Interrelationship of COVID-19 condition and Workers' Compensation:

Workers Compensation is designed to compensate employees for lost wages and for medical costs incurred as a result of either temporary or permanent disabilities resulting from an injury or occupational disease incurred at work. In May of 2020 the Workers Occupational Disease Act was amended to address COVID-19. Under that amendment for COVID-19 first responders and front-line workers who are infected with the coronavirus, "the exposure and contraction shall be rebuttably presumed to have arisen out of and in the course of the employee's first responder or front-line worker employment and the injury or occupational disease shall be rebuttably presumed to be causally connected to the hazards or exposures of the employee's first responder or front-line worker employment."

The term "COVID-19 first responder or front-line worker" is defined as "all individuals employed as police, fire personnel, emergency medical technicians, or paramedics; all individuals employed and considered as first responders; all workers for health care providers, including nursing homes and rehabilitation facilities and home care workers; correction officers; and any individuals employed by essential businesses and operations as defined in Executive Order 2020-10 dated March 20, 2020, as long as individuals employed by essential businesses and operations are required by their employment to encounter members of the general public or to work in employment locations of more than 15 employees. Therefore, this presumption would apply to CTA employees.

The presumption can be rebutted by evidence that the employer, in this case the CTA, was engaging in and applying to the fullest extent possible or enforcing to the best of its ability industry-specific workplace sanitation, social distancing, and health and safety practices based on updated guidance issued by the Centers for Disease Control and Prevention or Illinois Department of Public Health or was using a combination of administrative controls, engineering controls, or personal protective equipment to reduce the transmission of COVID-19 to all employees for at least 14 consecutive days prior to the employee's injury, occupational disease, or period of incapacity resulting from exposure to COVID-19.

REPORT OF THE PRESIDENT B/A KEITH D. HILL JUNE 2020 (CONT.)

The CTA in the greatest likelihood could probably meet this burden and overcome the presumption, which would leave the matter to the employee. The employee would have the burden like in any case to show his/her COVID condition was a result of a contact at work. The Act also allows the CTA to overcome the presumption by showing the employee was exposed to COVID-19 by an alternate source.

Where the CTA overcomes the presumption based upon facts the employee has given in any interviews or tracing or based upon the CTA's policies, the employee then has the burden and must establish a causal connection between his having COVID-19 and the workplace. Therefore, the employee having COVID most likely would not be enough to meet the employee's burden that "the COVID condition had its origin or aggravation in a risk connected with the employment or to have flowed from that source as a rational consequence."

2. Practical Results and Considerations:

It must be remembered Workers' Compensation is designed to make up for loss of earnings and provide compensation for medically related bills. The Amendment to the Act makes this clear in that it provides that an "employer is entitled to a credit against any liability" for temporary total disability due to an employee as a result of the employee contracting COVID-19 for A) any sick leave benefits or extended salary benefits paid to the employee under the Emergency Family Medical Leave Expansion Act, Emergency Paid Sick Leave Act of the Families First Coronavirus Response Act (FFCRA), or any other Federal Law or any other credit to which the Employer is entitled under the Workers' Compensation Act.

This offset is applicable to the CTA which fully compensates employees who are off for the first 80 hours under the FFCRA and thereafter compensates employees who have Corona at the full salary level. These payments not only are offsets but the CTA's policy more than compensate employees who do not receive full salary under Workers' Compensation. Therefore, there would not be any loss of wages for a CTA employee who has a temporary partial disability due to COVID -19 and is able to return to work. The only possible compensation would be for any medical bills that may not have been covered.

If the employee had some side-affect attributable to COVID 19 that caused a permanent partial disability that precluded the employee from returning to work at his/her regular job, then the employee could pursue a Workers Compensation claim like any other, and there would be additional damages for which the employee could possibly be compensated. The employee's burdens would be no different than any other case; the employee having to show a causal connection for the COVID condition and the resulting permanent partial disability. The death of an employee similarly could result in a claim. This would be the rare situation. Local Union 241 encourages you to consult with an attorney, because this was added to the law.

CALL TO ACTION

- > I would like the members to stand with the Local and be on the lookout for a few things.
- We need to bring attention and force the Mayor and the Governor to make our passengers wear a face masks, when riding our system. Be on the lookout for this action.
- The next action is, I think it is time we march! I find it very insulting that the top officials think it is ok for us to be attacked while we earn a living with no repercussion or assistance for us. I think the message that was sent out with the last incident has our riders thinking that it's ok for them to harass us and there will be no repercussions. I'm sorry we will not stand for this or except this as we perform our job, so let's fill the streets and bring some noise. Be on the lookout for this #CTALIVESMATTER.

I would like to give thanks to our Creator, whom is called by many names. I hope you and your families are in good health and in the best of spirits.

As the 2nd Vice President, I have the responsibilities to represent the Local and its members assigned by the President.

Please, to all Local 241 Members, continue to stay safe during this COVID-19, pandemic!

On or about July 2, 2020, Mayor Lori Lightfoot implemented for any members traveling outside of the state of Illinois, should be quarantined for 14 days upon return. (See attached bulletin)

I visited all garages, where I assisted our members with discipline hearings, discharge hearings and writing grievances.

I attended Step II grievance meetings via tele-conference. There were 43 cases: 38 won and 5 lost. With no attorney cost.

DRUG HEARINGS

There were approximately 17 cases.

- 2 members resigned.
- 2 members retired early.
- * 4 members have pending cases.
- ❖ 9 members entered into the EAP (Employee Assistance Program/SAP (Substance Abuse Program).

Here is a 6-month evaluation:

- January to June 2019, Local 241 members had 43 positive drug cases.
- January to June 2020, Local 241 members had 39 positive drug cases.

To all Executive Board Members and Stewards, please continue to have rap sessions, reminding our members that marijuana IS NOT LEGAL, while operating CTA buses.

The purpose of this policy is to establish a guideline to maintain a drug and alcohol free work place, and to reduce the probability of accidents or incident related to the use or misuse of alcohol and other drugs by employees. First time is a deterrent and second time is treatment and rehabilitation.

ORDER OF THE COMMISSIONER OF HEALTH OF THE CITY OF CHICAGO

No. 2020-10

(QUARANTINE RESTRICTIONS ON PERSONS ENTERING CHICAGO FROM HIGH INCIDENCE STATES)

Issued: July 2, 2020

WHEREAS, The City of Chicago, like other cities around the world, has been severely affected by COVID-19, with approximately 50,986 confirmed cases in the City as of June 24, 2020; and

WHEREAS, Through implementing rigorous and sensible public health measures, the City of Chicago has successfully slowed the transmission of COVID-19; and

WHEREAS, Mayor Lori E. Lightfoot has undertaken a cautious, incremental and evidence-based approach to reopening the City of Chicago; and

WHEREAS, Certain other cities and states are experiencing a significantly increased prevalence of COVID-19; and

WHEREAS, It is necessary and appropriate to put in place measures to reduce the spread of COVID-19 in Chicago as a result of people entering Chicago from high incidence states; and

WHEREAS, The Municipal Code of Chicago ("Code") authorizes the Commissioner of Health of the City of Chicago ("Commissioner") to implement emergency measures to stop the spread of communicable diseases, and to protect the health, safety, and welfare of the City's residents, including but not limited to authority granted in Sections 2-112-080, 2-112-160(a)(4), and 2-112-170 of the Code, in addition to 77 III. Adm. Code Sections 690.1310 and 690.1330; now, therefore,

The Commissioner of Health of the City of Chicago hereby orders as follows:

SECTION 1. All persons entering the City of Chicago from a state with a COVID-19 new case rate greater than 15 COVID-19 cases per 100,000 resident population per day, over a 7-day rolling average ("High Incidence State") shall be subject to mandatory self-quarantine for 14 days or the duration of the person's presence in Chicago, whichever is shorter, unless exempted in a protocol issued pursuant to Section 2 of this Order.

SECTION 2. The Commissioner shall issue protocols governing application of this Order. Such protocols shall include an exception to the self-quarantine requirement of this Order for "essential workers," as defined in the protocols. The protocols may include other exceptions to self-quarantine that in the sole judgment of the Commissioner are necessary or appropriate to cover situations when self-quarantine is not possible, practicable or advisable, provided such exceptions continue to safeguard the public health. Such protocols may also contain guidance for businesses to implement rules governing their employees' business and personal travel.

SECTION 3. The Chicago Department of Public Health shall make public the High Incidence States on its website.

SECTION 4. The Commissioner may take immediate action to protect the public from COVID-19 when a person enters the City of Chicago from a High Incidence State or jurisdiction, including, pursuant to City of Chicago Isolation and Quarantine Rules and 77 III. Adm. Code 690.1330, issuing a written or verbal order of quarantine to the person or group of persons.

SECTION 5. It shall be the duty of every person subject to this Order to comply with this Order. Any person who violates this Order shall be subject to applicable penalties provided by law.

SECTION 6. This Order shall take effect at 12:01 a.m. on July 6, 2020 and shall remain in effect until the Commissioner makes a written determination that the threat to public health posed by COVID-19 has diminished to the point that this Order can be safely repealed.

SECTION 7. If any provision of this Order or its application to any person or circumstance is held invalid by any court of competent jurisdiction, this invalidity does not affect any other provision or application of this Order, which can be given effect without the invalid provision or application. To achieve this purpose, the provisions of this Order are declared to be severable. This Order is meant to be read consistently with any Court order regarding this Order.

ORDER OF THE COMMISSIONER OF HEALTH OF THE CITY OF CHICAGO No. 2020-10

(QUARANTINE RESTRICTIONS ON PERSONS ENTERING CHICAGO FROM HIGH CASE-RATE STATES)

Issued: July 2, 2020

Section 3 of Order No. 2020-10 authorizes the Commissioner of Health to issue protocols governing implementation of this Order. These protocols, as may be amended from time to time, are set forth below in FAQ format for convenience.

Frequently Asked Questions

Q: Why is this order being issued and what does it mean?

A: In response to increased and high rates of COVID-19 transmission in certain states within the United States, and to add to Chicago's efforts to contain the spread of COVID-19, the City is issuing an order applicable to anyone coming into the City from designated states that have a significant degree of community-wide spread of COVID-19. This includes both Chicago residents returning from travel to a designated state, and travelers arriving in Chicago from a designated state. Anyone traveling from a designated state is directed to self-quarantine for a 14-day period or the duration of their time in Chicago, whichever is shorter, from the time of last contact within the designated state, subject to the limited exceptions set out below.

Q: When does the Order go into effect?

A: This Order goes into effect on Monday July 6, 2020, at 12:01AM.

Q: Where does the Order apply?

A: The Order applies to individuals arriving in the City of Chicago, while they are in the city. The city limits are defined in this <u>interactive map</u>.

Q: How will states be designated under the Order?

A: A state will be designated if it has a case rate greater than 15 new COVID-19 cases per 100,000 resident population, per day, over a 7-day rolling average.

Q: What states are currently covered by the Order?

A: A list of the states currently covered by the Order can be found here.

Q: Will the list change? When will it change?

A: The list of states will be reviewed and amended every Tuesday, starting July 14, 2020.

Q: What if I am traveling internationally?

A: Travelers coming from international locations are not covered by this Order and should follow Centers for Disease Control and Prevention guidelines.

Q: How long is the Order in effect?

A: The Order will be in effect until further notice, and any changes will be based on applicable public health guidance.

Q: What happens if I violate the Order?

A: Individuals found in violation of the Order are subject to fines of \$100 - \$500 per day, up to \$7,000.

Q: What if I arrived in Chicago before the effective date of the Order, do I still have to quarantine?

A: The Order impacts individuals who arrive in Chicago on or after the effective date of July 6, 2020. If you arrive in Chicago prior to that date, the Order does not impact you. However, all individuals are expected to follow the latest <u>public health guidance</u> for Chicago.

Q: What if I had a connecting flight through one of the designated states but did not stay there?

A: The Order does not apply to any individual passing through designated states for less than 24 hours in the course of travel.

Q: What if I drove through one of the designated states but did not stay there?

A: The Order does not apply to any individual passing through designated states for less than 24 hours in the course of travel.

Q: What if I was in a designated state and then traveled to a non-designated state before arriving in Chicago? Do I still need to quarantine?

A: Yes, if you spent longer than 24 hours in a designated state, you must quarantine for 14 days from the time of last contact within the designated state, even if you spent time in a non-designated state for a period after being in the designated state and before arriving in Chicago.

Q: What if I have to travel for my job?

A: Travelers coming to Chicago for non-essential business and residents returning to Chicago from a designated state must adhere to the quarantine guidelines, subject to the limited exceptions set out below.

Q: I already had my flight booked/trip planned, do I still have to follow the quarantine Order?

A: Yes, all travelers arriving from designated states on or after the effective date of July 6, 2020, are required to follow the guarantine Order, subject to the limited exceptions set out below.

Q: What if I came from one of the designated states and am staying less than 14 days? A: The mandatory self-quarantine is for a period of 14 days or the duration of the individual's presence in Chicago, whichever is shorter.

Q: What does it mean to quarantine?

A: Quarantine helps prevent the spread of disease before a person knows they are sick, including if a traveler has been infected with the virus but does not have symptoms. Under this Order, quarantine means staying at a single designated home or dwelling for 14 days before doing any activities outside of the home or dwelling. People in quarantine should separate themselves from others as much as possible and check themselves for symptoms. Additional requirements under quarantine include:

- The individual must not be in public or otherwise leave the dwelling that they have identified as suitable for their quarantine, unless seeking medical care or COVID-19 testing.
- If seeking medical care or testing, or when traveling to or from the airport, train station, or bus station (if applicable), a face covering must be worn and public transportation must not be used.
- Food and other needed supplies must be delivered to the individual's dwelling; the individual may not leave the premises to acquire supplies.

- The traveling individual or family group should be situated in separate quarters with a separate bedroom and, if possible, separate bathroom facility from non-traveling household members.
- The individual must self-monitor for symptoms potentially consistent with COVID-19. If any symptoms develop, the individual may leave the dwelling to receive testing for COVID-19 but then must return to complete the 14-day quarantine while isolating from other household members, regardless of the test result. A face covering must be worn while seeking testing.

Q: I don't have any symptoms - do I still have to quarantine?

A: Yes, all travelers from the designated states must quarantine for the full 14 days, subject to the limited exceptions set out below. Individuals can develop symptoms and become contagious up to 14 days from their last exposure.

Q: What if I get tested and am negative - do I still have to guarantine?

A: Yes, even individuals with a negative test result must quarantine for the full 14 days if coming from a designated state. Individuals can develop symptoms and become contagious up to 14 days from their last exposure.

Q: My family/friends are coming from one of the designated states and are staying with me - do I have to quarantine too?

A: No. Traveling individuals are encouraged to self-quarantine in the home they are traveling to in Chicago and should avoid close interactions with non-traveling household members until the 14 days have passed. Other household members who did not travel from a designated state are not required to self-quarantine.

Q: I'm returning from one of the designated states - can I go to work or is that a violation of the Order?

A: All travelers returning to Chicago from the designated states must self-quarantine for 14 days, subject to the limited exceptions set out below.

Q: Are there any exceptions to the Order?

A. For purposes of the Order and this FAQ, "essential workers" are not subject to the mandatory self-quarantine under the circumstances described in (a) and (b) below. An "essential worker" is a person who works in <u>critical infrastructure as designated by the Cybersecurity and Infrastructure Security Agency</u> ("primary work") and:

- (a) if a non-resident of Chicago, is traveling from a designated state to Chicago for the primary purpose of carrying out primary work in Chicago, and who needs to be physically present in Chicago in order to carry out that primary work, certified in writing by the worker's employer and made available for review by authorized officials from the Chicago Department of Public Health and Chicago Police Department, or
- (b) if a resident of Chicago, is returning from a designated state, and was in the designated state for the primary purpose of carrying out primary work in that state, and who needed to be physically present in that state in order to carry out that primary work, certified in writing by the worker's employer and made available for review by authorized officials from the Chicago Department of Public Health and Chicago Police Department.

"Essential worker" includes any state, local, and federal officials and employees traveling in their official capacities on government business, including military service.

Essential workers traveling for work purposes are subject to the following requirements:

- Essential workers should avoid any non-essential interactions until the quarantine period
 has ended. They must limit their activities to work-related activities and functions that
 directly support their work-related activities, and avoid public spaces as much as
 possible.
- Essential workers should monitor temperature and signs of symptoms, wear a face covering when in public, maintain social distance, and clean and disinfect workspaces.
- Essential workers are required, to the extent possible, to avoid extended periods in public, contact with strangers, and large congregate settings.

Exceptions to the Order for personal travel will be permitted for travel for medical care and parental shared custody. The Commissioner of Health may additionally grant an exemption based upon an organization's or business' testing and other control policies or in extraordinary circumstances, which warrant an exception from mandatory quarantine, subject to the terms and conditions applied to essential workers or terms and conditions otherwise imposed by the Commissioner in the interest of public health.

Q: How will this information be updated? How will travelers be notified?

A: The Order and its effects will be communicated through messaging on highways, at airports, on the City's website, and through social media. Hotels and short-term rentals will be asked to communicate the 14-day quarantine to guests who have traveled from one of the designated states.

CTA LEAVE POLICY ADDENDUM FOR ESSENTIAL BARGAINED-FOR EMPLOYEES

EFFECTIVE DATE: March 17, 2020

AMENDED: JULY 4, 2020

I. PURPOSE

The CTA is committed to providing a safe work environment for all employees. The CTA's objective during the COVID-19 outbreak is to continue providing services while ensuring the safety of its employees and the general public.

II. GENERAL POLICY PROVISIONS

- A. The CTA's Administrative Procedures (APs), including AP #1010, remain in effect.
- B. For purposes of this policy, "isolated" means a person who has been diagnosed with COVID-19 virus and has been directed or ordered into isolation at home or in a medical facility by a public health agency or physician. "Quarantined" means a person who has not been diagnosed with the COVID-19 virus, but who has been directed or ordered into quarantine by a public health agency or physician.

III. ABSENCE DUE TO COVID-19 ILLNESS OR ISOLATION ORDER

- A. During the COVID-19 outbreak, the CTA will provide additional paid time off to any employee who is absent due to contracting the COVID-19 virus, or has been directed or ordered to isolate themselves by a public health agency or physician. Such an employee will not be required to use his or her normal benefit time.
- B. The employee must report their absence to their Department as soon as possible. The employee will be required to provide reasonable evidence to support any absence for this reason. Such documentation may include, but is not limited to, an order from a public health agency or physician directing them to isolate due to contracting the virus.
- C. Employees must continue to follow the absence reporting procedures described in AP #1010.

IV. ABSENCE DUE TO DIRECTED OR ORDERED QUARANTINE

- A. If an employee is absent from work due to a quarantine order from a public health agency or a physician, and the employee is not currently ill or exhibiting symptoms of COVID-19, the employee should first work with their Department to determine if telework is feasible pursuant to the CTA Telework Policy for COVID-19 Outbreak.
- B. If it is not feasible for the employee to work from home, the CTA will provide additional paid time off to any employee who is absent due to a directed or ordered quarantine. Such an employee will not be required to use his or her normal benefit time.
- C. For policies related to travel-related quarantine, see Section V below.
- D. If the employee becomes symptomatic or ill, they must report the change in their condition to their manager as soon as possible.
- E. The employee must report the directed or ordered quarantine to their manager as soon as possible. The employee must also notify Human Resources (HR) by calling the Benefits Hotline at 312-681-2225, press "3", or benefits@transitchicago.com. The employee will be required to provide reasonable evidence to support any absence for this reason. Such reasonable evidence may include, but is not limited to, a copy of an order or directive to quarantine.

V. ABSENCE DUE TO EMPLOYER MANDATED TRAVEL-RELATED QUARANTINE

- A. Any employee who has visited a country or region that is listed on the CDC's Geographic Risk Assessment for COVID-19 Transmission list as a Level 3 country will be ordered to stay home and monitor their health for 14 days following his or her return.
- B. The Commissioner of Health of the City of Chicago has issued an Emergency Travel Order for Chicago residents and visitors regarding interstate travel. Effective Monday July 6, 2020, at 12:01am travelers entering or returning to Chicago from states which CDPH has identified as experiencing a surge in new COVID-19 cases are directed to quarantine for a 14-day period from the last date in that state. Therefore, any CTA employee returning from one of the identified states on or after July 6, 2020, must quarantine according to this guidance.
- C. If an employee returns from travel to a country listed as a Level 3 or a state identified as high-incidence by CDPH, and the travel to the country occurred prior to the country being listed as a Level 3 country or to the state prior to it being identified as a high-incidence state, then the employee should first work with their Department to determine if telework is feasible pursuant to the CTA Telework Policy for COVID-19 Outbreak and, if not, the CTA will provide additional paid time off. The employee will be asked for documentation or certification verifying the dates of travel.
- D. If an employee returns from travel to a country listed as a Level 3, and the travel to the country occurred after the country was listed as a Level 3 country, the employee will be allowed to use their own normal benefit time to cover their absence.
- E. If an employee returns from travel to a state identified as a high-incidence state, and the travel to the state occurred after the state was identified by CDPH as a high-incidence state requiring quarantine, the employee will be allowed to use their own normal benefit time to cover their absence for quarantine.

VI. ABSENCE DUE TO AN ORDERED SCHOOL CLOSURE

- A. Any employee who needs to remain home due to an ordered school closure to care for a minor child, may use their benefit time to cover the absence from work. If an employee has exhausted their paid benefit time, the CTA may advance the employee's benefit days at the Authority's discretion.
- B. The employee may be asked to provide verification.

VII. TIMEKEEPING

- A. Employees are required to report their absences from work in accordance with AP #1010.
- B. For COVID-19 related absences as outlined in Sections III, IV, and VI above, timekeepers should indicate the absence is related to COVID-19. Activity code: 94813.

VIII. REASONABLE ACCOMMODATIONS

A. Employees who believe that they require a reasonable accommodation related to the COVID-19 outbreak may request an accommodation pursuant to AP #1017.

IX. RETURN TO WORK

- A. Employees who were absent from work due to an illness or injury, including contracting the COVID-19 virus, should follow the Return to Work Procedures in AP #1010.
- B. No return to work certification is required if the employee did not have an illness or injury but was absent from work due to an ordered school closure.

MAINTENANCE AND FIRST TRANSIT REPORT

General Clean

Several Bus Servicer who picked General Clean has not been doing the General Clean Job during the entire duration of the Garage Pick, as I ask CTA why even have a pick job when you going go pick and choose when I get to you the job I picked. Local Union 241 filed a grievance on this matter and we filed an Unfair Labor Practice at the Labor Board as well. It was reported to Local 241 by CTA that we are (10) ten Bus Service down, that is the reason why no regular Bus Servicer are doing General Clean.

Now they are hiring Bus Servicer Apprentice at a alarming rate. During the Pandemic Bus Servicer Apprentice was the only people that was getting hired off the street, we can clearly see if we allow Bus Servicer Apprentice to continue to do General Clean and our Regular Bus Servicer who picked General Clean is not doing the work we will loose the position. The one great thing that came out of the last 2018 contract is that we put all position in the contract.

Remember we lost the Body man Position, Scrubber Position, we were able to keep the Janitor Position, this position name was changed to GARAGE SERVICER, the arbitration made it clear that they can change the name but the function of the pick job remains the same. The arbitrator stated when we lost the jobs the union never consistently file a grievance. So, from this point on, whoever picked General Clean and Management do not allow you to do your pick job a grievance will be file.

As I reported last month changes will take effect to our General Cleaning, when a Bus Servicer Apprentice work on a 60 ft. bus, from this point on it will be two apprentice splitting the job, one will do the front half of the bus and the other will do the back half of the bus, the front half will start at the front bumper and end at the front of the accordion. The rear half will start at the inside of the accordion and end at the rear bumper. Afterward the employee will do a 40 ft. bus. This process will take a total of 7 hours. Reminder one 60 ft. bus takes (6) six hours to clean and one 40 ft. bus takes (4) four hours to clean.

COVID-19

This pandemic is still here, death is still occurring, and we are not taking this serious, I encourage you to ware you mask, practice Social Distancing, and if you are sick STAY HOME, use the 7 day sick claim, who has been in the regular employ of the Authority for not less than twelve (12) months, be absent from duty due to sickness or accident not related to his employment and should any employee who has been in the regular employ of the Authority for not less than ninety-one (91) days be absent from duty due to an accident related to his employment, and provided the employee is under the care of a regularly licensed physician for such incapacity, the Authority will pay the employee's regular wages on the following basis:

(a) If the employee's absence is due to an accident, the Authority will pay the employee's regular wages for the first seven (7) days of such incapacity. (b) If the employee's absence is due to sickness, the Authority will not pay the employee's regular wages for the first two (2) working days of such incapacity,

but will pay the employee's regular wages for the third, fourth, fifth, sixth and seventh working day of such incapacity.

Verification of illness by a licensed physician shall constitute proof of claim. Final verification must be approved by the Authority's physician. After the Second Day you must call the Reedgroup and get a claim number. Group Accident and Sickness Coverage, providing no indemnity for the first seven (7) days of incapacity, but providing two hundred fifty dollars (\$250) per week thereafter, not to exceed twenty-six (26) weeks for each full-time regular employee actively employed who has been in the employ of the Authority continuously for not less than twelve (12) months.

The Group Accident and Sickness weekly benefits shall be paid on a five (5) work day basis. The Group Accident and Sickness Coverage will be provided at the expense of the Authority. Said Accident and Sickness Coverage shall not cover any period of incapacity for which the employee is entitled to indemnity or compensation under any Workers' Compensation Act; provided, however, that the Authority shall be liable to the extent of the difference between two hundred fifty dollars (\$250) per week and such weekly compensation allowance, if less than two hundred fifty dollars (\$20) per week, for a period not to exceed twenty-six (26) weeks. Accident and Sickness benefits will not be paid for any day for which sick pay benefits are paid under the seven (7) day sick pay benefit.

CONTACTED COVID-19

If you contracted the virus you must do the following:

- Contact your Senior Manager and provide him the paperwork
- Contact the Reedgroup and get a Claim Number
- Send all documents to <u>Benefits@transitchicago.com</u> and your Senior Manager

We have too many members pay are being delayed due to not following these simple rules, we have several members who claim that they were never given the instructions.

Commissioner of Health Travel Order

Effective Monday July 6, 2020 if you travel to the 15 states that is listed on the Travel Ban, you must quarantine for a 14 – day period. Local 241 are aware a lot of our members have already booked vacations and may have to take their kids to collage or funerals and wedding, to attend. These are obligations. To be paid for these invertible life function you mut file a sick claim with the Reedgroup and after the first (7) seven days you will fall under the (26) twenty-six-week sick pay benefits, as listed in the section COVID-19 of this report.

Grievances

The month of July Maintenance have cases on the docket for Expedited Arbitration, we have won close to all grievances for overtime. If you're being passed up for Overtime you should reachout to your Union Steward and file a grievance. Not only for overtime, if your job is being back filled, or you're not doing your assigned job Fill Out a Grievance! Stop being FRIENDS with Management because they are going to add more and more to your job function during the 8 hours you are at work, they are expecting 8 hours of work for 8 hours of pay. They don't take in consideration your break time and your 10-minute clean up time that's contractual. They will tell you to your face "your time and seniority do

not mean nothing only for picking vacation", I keep repeating that Management Disrespect is at an all time high, and the only way to get your respect back is to do your job without the extras, such as when Management as you to do them a favor, and they can't help us, well we all favored out. At 77th Street garage they are not doing overtime, why because the disrespect of Management, this has opened Management eyes. Upper Management are telling lower Management to stop with the disrespect. I have been out many of nights recently dealing with this issue. Managers at Forest Glen are under the microscope because employees are not taking the disrespect.
