FOR OUR WORKERS:

• On November 8th, Vote Yes for Workers' Rights

When we all do better, it makes Illinois stronger. This November, workers are on the ballot. Voting Yes on the Workers' Rights Amendment will update the Illinois Constitution to guarantee every Illinoisan has the right to join together with other workers to negotiate for better pay, improved benefits, and safe working conditions.

The Workers' Rights Amendment will put more money in the pockets of workers who join together for negotiating raises, helping working families deal with rising costs while making our economy and our communities stronger.

The Workers' Rights Amendment helps us build an economy that works for every Illinoisan. It helps families by guaranteeing workers' rights to join together to negotiate for pay raises, lifting workers' pay to help deal with rising costs, and helping create good-paying jobs available to all workers.

The Workers' Rights Amendment protects all Illinoisans, on the job and off. It ensures workers can speak out about dangerous situations that put all Illinoisans at risk without fear of retaliation from their employer.

EXPLANATION OF AMENDMENT:

The proposed amendment would add a new section to the Bill of Rights Article of the Illinois Constitution that would guarantee workers the fundamental right to organize and to bargain collectively and to negotiate wages, hours, and working conditions, and to promote their economic welfare and safety at work. It would also prohibit from being passed any law that interferes with, negates, or diminishes the right of employees to organize and bargain collectively over their wages, hours, and other terms and conditions of employment and workplace safety. At the general election to be held on November 8, 2022, you will be called upon to decide whether the proposed amendment should become part of the Illinois Constitution.

REPORT OF THE PRESIDENT B/A KEITH D. HILL AUGUST 2022(CONT.)

SECTION 25. WORKERS' RIGHTS:

Employees shall have the fundamental right to organize and to bargain collectively through representatives of their own choosing for the purpose of negotiating wages, hours, and working conditions, and to protect their economic welfare and safety at work. No law shall be passed that interferes with, negates, or diminishes the right of employees to organize and bargain collectively over their wages, hours, and other terms and conditions of employment and work place safety, including any law or ordinance that prohibits the execution or application of agreements between employers and labor organizations that represent employees requiring membership in an organization as a condition of employment. (b) The provisions of this Section are controlling over those of Section 6 of Article VII.

PACE WEST:

- I'm pleased to announce that the Brothers and Sisters of PACE West have a contract!!! This administration of Local 241 has delivered its eighth contract with no loses or give backs;
 - The minimal increase is 11% in wages.
 - o The members will have the right to use one sick elective day every four months.
 - We reduced the progression time on making it to top pay by one year.
 - The pension multiplier was increased to 1.875%, this will really help those seeking to retire after Jan 1, 2023.
 - We implemented a training program for Mechanic Helpers to advance to mechanics.
 - One of the biggest things that I think in this agreement is giving our members the right to challenge an accident, by way of arbitration instead of the National Safety Council. This process was so unfair to the members of Local 241 at PACE, the Council voted with PACE 99% of the time. The deck was stacked against our members, they had to turn in a written report to PACE who took the report and wrote their own report and sent it to the council. The members could not see what PACE wrote or submitted.

I'm so happy to see the members have a faster and fairer process. We started negotiations in June and I hope the members are pleased.

REPORT OF THE PRESIDENT B/A KEITH D. HILL AUGUST 2022(CONT.)

PACE NORTH SHORE:

Local 241 will be starting contract talks with PACE on September 13, 2022 as this Local prepares to bring its ninth contract to the members with no loses or give backs. We will keep all updated, we're still looking for members to join us on the committee.

EXPEDITED AND PRE-ARBITRATION & LABOR CHARGES:

- In the Month of August, Local 241 did not hold Expedited Arbitration. Local 241 will be addressing over 300 grievances in the month of September.
- This administration will keep addressing the grievances and keep working to reduce the amount of time members must wait on receiving a final decision.
- Pre-Arb was not held in August but Local 241 will be holding two (2) sessions in the month of September.
- Labor charges in the month of August: We had one new case. The Local also had one case dismissed.
- We also had (2) letters of complaints/charges written to the International Office against the Local;
 (2) were responded to and all complaints/charges were dismissed and closed as unfounded.

LABOR MANAGEMENT MEETING:

- In the month of July Local 241 held three (3) labor-management meetings two (2) with Kedzie and three (1) with North Park garages.
- In these meetings we talked about the morale of the operators what can we do to change the environment at these locations. We also discussed grievances and talked about bullying operators during the interview process.
- Remember we are the managers' customer, and they should treat us with respect, if you feel this is not happening reach out to the Union.
- We also met with Control and Bus Operations to discuss fallbacks and how they talk to the operators in our time of need.

<u>REPORT OF THE PRESIDENT B/A</u> <u>KEITH D. HILL</u> <u>AUGUST 2022(CONT.)</u>

PICK OF RUNS:

- In the Month of August, the members participated in a run pick at all locations. This was really the first run pick with a full-time only workforce.
- Let's kill this rumor, the Union does not sign off on picks!!! We see the pick a few days before it is posted, we try to make adjustments moving forward. This method is not working for the Local Union or the members.
- First let me say, it's time to take a stand on the quality of work that CTA puts out. So, with this run pick the Local is starting to lay the ground work for change.
- If we need to pick 38.5 hours to meet the guarantee to be full time to be paid 40 hours the runs should reflect this, we should be able to pick a run 5 days without worrying about if it equals enough hours.
- As we take on this fight to make sure we have better runs, work with us. For all members who picked under 38.5 hours meaning less than 38.4 hours or lower will be paid the guarantee. You will be brought up to 40 hours.

SAFETY:

- Local 241 participated in a safety meeting with CTA and Local 308. The members who participated for Local 241 were, myself President Hill, Executive Board Member Clarence Covington and Steward Rashida Tramble. In this meeting we excepted the safety plan for the rails/Local 308 to meet the states deadline.
- In the upcoming weeks Local 241 will be holding safety meetings at 103rd Street garage and 74th Street garage to address our troubled areas with CPD and management.
- Since the month of June, we have gone from 6 buses to 70 buses with the shields and we will keep pushing to get more done. I'm asking the members to keep the Union informed about troubled areas so we can push to get us help.

PANEL DISCUSSION:

- Local 241 accepted and participated in a panel discussion with U.S. Labor Secretary Marty Walsh, U.S Rep. Jan Schakowsky, U.S. Rep. Bill Foster. This discussion centered around the Multi-Employer Pension rescue as part of the American Rescue Plan. We also discussed other Labor issues like our safety and ridership and the future of transit. This is the second time I've had the opportunity to talk with Secretary Walsh about our issues.
- > This is another step to keep Local 241's issues in the forefront.

We had large turnout which tells me that the Members understand how important it is to educate themselves and each other.

MAILED ATU CHECKS

In order to remain transparent and to further update the Membership, I would like to address email correspondence that was sent to Local 241 from the bank. The email was sent to us as a reminder of the ongoing investigation. The bank went on to say that these types of investigations can take up to a year to find resolution. Our bank has assured us that they have made many internal changes to insure that customers deposits are safe.

One of the things that was highlighted in this email from the bank was: "Unfortunately as long as checks continue to be generated and circulated, these incidents may continue to happen." We would like to thank the Members for your patience as we continue to seek resolution.

60th ATU International Convention

Judgement on Road-calls

Last month I reported on the Disabled Bus Field Procedure and the thing we need to do to protect the Maintenance Department against Management when we go on Road-calls. At the end of this report, you can read the Disabled Bus Field Procedure that I wrote last month.



NO ONE has the Right or the Authority to make you drive something that is Unsafe NO ONE. The above picture was called in by an Operator for a road-call, the Manager at the garage gave this to the Instruction Department because it was new mechanics being trained. New Mechanic this issue has been addressed you must not be taught that this is acceptable, if you're on a road-call and you think this is unsafe and the Tow Truck Driver or the Supervisor wants to drive the bus in, REFUSE IT even when you are given a Direct-Order and it is UNSAFE Refuse the order and let them do the unsafe act.

What make that manager think that If the Bus Operator could not drive that bus safely, SO WHAT MAKE YOU THINK THAT THE Maintenance Employee not allow to call for a Tow. *Maintenance if you need a tow CALL FOR A TOW, you make the call.* Don't be that HERO Employee that drives that bus in and kill someone or yourself, looking at the picture above someone played the HERO that day.

First Transit Bid Pick

First Transit will be conducting the Pick in September and it will go into effect the in September. So leave if your pick number is 30 you should leave 30 pick choices. Is your pick number is 70 then you should leave 70 pick choices. If you do not and your pick comes up, I will pick for the closest spot you had on your previous pick.

<u>Overtime</u>

Overtime is Wide Open at all garages for Mechanic and Servicers.

PACE (West) (Southwest) (Northshore)

Employee Assistance Program for pace is to assist with the employee personal, work-related and emotional concerns. Pace is not like CTA if you have a substance abuse problem, no matter how long you've been at Pace if you piss dirty you will be up for termination. But at the CTA you have a chance to enroll into the drug – alcohol program.

If you are getting overwhelm and need help with separation/divorce, dealing with management or difficult co-workers, grief and loss, depression, mental health, the number you can call is 1-866-440-6556. The EAP is brought to you by Humana and Pace connecting communities.

Bus Maintenance Training Program

History of Excel, the excel program sets levels that can be reached by taking and passing tests through the Training Center, you would receive an increase in pay when you reach various levels of classes and testing. The problem with that is hard to into the training center. Nothing in the Excel Program outlined on how the training would be distributed, example; New Mechanics would stay in the training center for (5) five month and receiving all the training before being released to the garage, then come to pick with (5) five months of services could get Days' because senior employees could not take the class who asked for the classed for years. Currently Marqueal Williams have won Several Grievances making CTA to place Mechanics into the training class before the next system pick, with proof that you requested the class for months, so you see how Bus Excel did not work from 2005-2020.

Before I took office in March of 2015, I was the Executive Board Member Northside Maintenance, in the Contract we had Bus Excel in order to get a quality pay for the Maintenance Department. From 2005 through 2019 not one \$ dollars was spent saving the CTA Billions of Dollars so we removed this program from contract language because there was no repairing the wording in Bus Excel.

So, in 2020 the current contract negotiations with the Chicago Transit Authority, we were told at the Contract Negotiation Table that "the Maintenance Department is in need of a Training Program in order to receive the raises that you're fighting for", so Marqueal Williams along with ATU International made a national credited training program we brought to the table and it was accepted by the CTA.

The new Bus Maintenance Program is structured to get the members involved and bring fairness to everyone Mechanics and Bus Servicers and there is limitations for Bus Servicer Apprentices, this program is structured to give sufficient increase in pay by the classes you took, this program is also structured to allow the Senior Members who was left out in the cold to get Collage Credited Training

and be able to pick as a senior member, and this program also protect the older mechanics' who are nearing retirement.

For Bus Servicer and Bus Servicer Apprentices who are encourage to learn how to work on Electric Buses but does not have the time or money to attend outside training source for advancement this program is structured for you to attend training.

First Stage, we are at is Government Grants so far, we are approved for State Funding, \$10,000-\$15,000 Per-Person enrolled in the Program, and we are waiting or Government Federal Grant before we actually start adding the collage criteria in addition to Local Union 241 members training. The collage criteria are only stating when our instructors train us, we will receive collage credit for each course. On September 12, 2022 Local 241 and CTA will establish a Labor Management Committee to get started now that we have the State Funding. And when we get the Federal Grant Funding, we will start the class criteria's.

We have our own members creating confusion about this program, this program is totally on a volunteer basis, nothing Mandatory, this program is not structured to remove jobs as curtain people is telling members, or it will not affect you picking rights. Let's stop all the rumors and contact Marqueal Williams directly if you have any questions. Also let's stop curtain people from spreading negativity and controlling our advancement.

WORKERS' RIGHTS AMENDMENT

Illinois has a chance to make history and protect collective bargaining rights in the November 2022 elections, the Illinois General Assembly voted to put the Workers' Right Amendment on the ballot this year for voter approval, this amendment protects organizing and collective bargaining rights and stop politicians from intervening in the agreements reached by union workers and their employers.

Unions working together with the AFL-CIO, American Federation of Labor and Congress of Industrial Organizations is the largest federation of unions in the United States it makes up 56 national and international unions together representing more than 12 million active and retired workers. ATU, IBEW, AFSCME, is just some of the unions working hard to make sure workers' rights and collective bargaining is protected. Collectively Bargain grows jobs and deliver economic growth most effectively, strong economics are built from the middle out, not the top down. Building a stronger, more vibrant middle class will provide all workers with a more direct path to economic opportunities. Passage of the Workers' Rights Amendments will protect Illinois workers from political attacks and it will benefit working families, business and the state economy.

Disabled Bus Field Procedure

The operator of the Disabled Bus must establish a "Safe Zone" when you arrive on to the road call and determine that the bus is not in a safe zone, (in the middle of 1-94) before you relinquish the good bus, the Operator and the Supervisor MUST make every effort to put that bus in a Safe Zone for the Maintenance Employee. If the bus is not in a Safe Zone "DO NOT RELINQUISH THE BUS YOU CAME ON" until you get established that the Supervisor will remain on the scene.

You must make sure that you have a way to reach the CTA Control Center, the Bus Garages do not have a Mobile Device or care to give you one, we once had a garage cell phone when we go on road calls, also the Manager will not allow us to carry one of the Supervisor Radio for us to have a way to call the Garage or Control because guess what when we go on a dead motor, the entire bus is DEAD and we have no recourse to call the Bus Garage or Control, besides the bus supervisor, also when you call the garage and you're out on an emergency road call, (9) nine time out of (10) ten we get no answer from the garage management, you must get in contact with the CTA Control Center in an emergency situation, or call 911.

Personal Point this what kills me is the Authority make no kind of effects to make sure we are ok while on the Road Call, but when we get back to the garage, we have to be harassed by Management asking "who gave you permission to call for a tow", as if Management got off their ass to go out and diagnosis a bus. What make that manager think that If the Bus Operator could not drive that bus safely, WHAT MAKE YOU THINK THAT THE Maintenance Employee not allow to call for a Tow.

Maintenance if you need a tow CALL FOR A TOW, you make the call. Especially AT CHICAGO AVE GARAGE, PRESIDENT KEITH HILL, MARQUEAL WILLIAMS AND THE ENTIRE EXECUTIVE BOARD OF LOCAL UNION 241 STANDS BEHIND THIS. Don't be that HERO Employee that drives that bus in and kill someone or yourself. Keith D. Hill President - Business Agent




