Below is my report for the month of September 2022, presented to the Executive Board on September 30, 2022 and the Members on October 4, 2022 during the Mass Membership Meeting.

AWARD:

- April 2017 the union treasury had a little under \$600,000 in the bank and more than \$200,000 in bills, shortly after taking office our first audit was given to the board from the previous administration. This audit had 5 deficiencies ranging from no receipts for the cash being spent out of petty cash to going over the monthly amounts being spent out of petty cash and overall poor records of the members' money. I will never forget the look all the officers had on their face after the meeting with the auditors.
- From every audit thereafter, we have had no deficiencies so, from this administration and Sister Bowers' first audit to present day, we have had clean audits with no deficiencies. The board and I want to say **"THANK YOU"** because without you looking over and approving or saying no to things and following the bylaws, this would not have been possible! The officers putting in countless hours stepping up in different areas to help curb and cut cost played a big role.
- To our Financial Recording Secretary-Treasurer who has made all this possible by holding this together and making sure nothing wrong was done, to Financial Recording Secretary-Treasurer making sure this local followed the bylaws and every bill was paid, to our Financial Recording Secretary-Treasurer working with us to growing the union treasury from \$600,000 to \$2.1 million dollars that is the most money 241 has had in the bank in our history. Despite all the rumors of stealing money, the rumors of mismanagement to dragging the union's name in the mud, she kept her focus and guarded the members' money.
- (15) straight audits later with not one bad mark, not one deficiency, nothing but a clean clear audit, she has been recognized by the international, at the convention, for this and the only union to receive this award this year was our Financial Recording Secretary-Treasurer Toi Bowers. I want to thank Toi, the board and officers for this and say congratulations!!

PACE WEST CONTRACT:

- I would like to thank the members of PACE West for taking the time out to exercise your right to vote. PACE Board has voted and approved our Tentative Agreement, we are working on a date for the back pay and bonus. We've also resolved all the open grievances and waiting on the final document to be signed. All members will be paid and made whole once everything is final.
- Brothers and Sisters please report all incidents that happen on or off the bus to PACE.
- No one at PACE should be recording anyone without their permission!!! And no one should be disciplined off of another person's recording, if you have any problems with this reach out to the union.

PACE NORTHSORE:

- We have started contract talks with PACE Northshore, we have exchanged proposals and signed the rules of negotiations.
- We have over 60 proposals from the members of Northshore on the table to start the negotiations with and will be working from this. We will be at Northshore in the upcoming weeks to discuss with the members.

EXPEDITED AND PRE-ARBITRATION & LABOR CHARGES:

- In the month of September, Local 241 did hold expedited arbitration hearings, we took (250) cases over winning (165) in some form.
- This administration will keep addressing the grievances and keep working to reduce the amount of time members must wait on receiving a final decision.
- Pre-Arb was held in September winning (18) out of (24) cases. Please welcome our brothers and Sisters back to work.
- Labor charges in the month of September, we had no new cases. The Local also had three (3) cases dismissed.
- We also had no letters of complaints/charges written to the international against the local

CTA PENSION:

- INSPITE OF ALL THE CHALLENGES FROM THE STOCK MARKETS AND THE UNCERTAINTY OF THE FUTURE, **I AM PLEASED TO ANNOUNCE, FOR THE 4TH YEAR IN A ROW, THERE WILL BE NO INCREASE IN PENSION CONTRIBUTIONS!!!**

SAFETY:

- Local 241 will participate in a few safety meetings in the upcoming month with CTA and Local 308, the members who participated for 241 were myself, President Hill, Board Member Clarence Covington and Steward Rasheeda Tramble. In these meetings, we will be pushing the safety issues that concern our members on and off the bus. We will keep all updated.
- In the month of September, Local 241 held a safety meeting at 103rd Street Garage where the members addressed their concerns to CPD, CTA management and Security for the CTA.
- 74th will have a chance to address their troubled areas with CPD and management in the month of October on the 7th tentatively as of now, so please look for the notice.
- I have set up the same safety meetings for PACE West, PACE Southwest and PACE Northshore. I will keep all updated on committee members and dates in the future.

CELLPHONES:

- I'm asking all to stop using your cellphone to call control. If it is not an absolute emergency, please use the equipment on the bus.
- I'll start by saying if you are being harassed by a passenger and you need to call the control center, please do not step off the bus to do this!!! Call control from the bus
- When using your cellphone sometimes to call control, it might be hard to obtain the recording of the call if needed. I'm asking all if it is not an emergency, please use CTA equipment to notify control and not your cellphone.

TRANSIT HEARING:

- I had the opportunity to allow (15) members and some board members to hear an exchange between myself and a committee of aldermen, I had the opportunity to correctly explain the reason for the wait of buses on some routes.

TRANSIT HEARING (Cont.):

- The first meeting was called by Alderman Carlos Ramirez-Rosa of the 35th Ward, who had already talked to someone from the union about the ghost trains and buses. I explained the dangers of this to our membership and how it would force the CTA to make changes that would be an unstructured reduction in the workforce.
- After this meeting, the Alderman had a better understanding and agreed to talk with the union officers in the future.
- The second meeting was with the city council and neither union spoke during this meeting but the focus was on updating the technology to be more accurate and push the CTA to agree to not layoff anyone during this time and do more hiring.


ATU 2022 CONVENTION:

OFFICIAL ANNOUNCEMENT OF THE GENERAL ELECTION (2022)

This is the official announcement of Local 241's General election. Election notices have already been mailed out and submitted as a part of my report. Nominations will be held on November 1, 2022 and the General Election will be held on December 6, 2022. If Necessary, a Run-Off Election will be held on December 20, 2022.

60th ATU International Convention

The ATU Convention was held in the Las Vegas, Nevada on September 18-24, 2022. Prior to my arrival, I was notified by the ATU International that I was selected as the Chairwoman over the Financial Secretaries for this year's Convention. I presided over the International Secretary's Committee, which included auditing the finances of the ATU and providing the Convention with my final report.

I was also awarded the Financial Secretary Treasurer's Award for excellence in financial reporting. After 15 straight audits with no deficiencies and presiding over a healthy treasury, I am proud to be recognized by the ATU International for the hard work that we accomplished as a Local.

Six Month Audit Preparation

All bills are paid or current. Local 241's 6-month audit is still underway. As always, I will keep the membership informed of the results as soon as they are available.

Grievances

The total amount of open grievances for the month of September 2022 is **1796**. Local 241 is still holding the line on the grievances. We have been able to drastically reduce the wait times of our members were experiencing in order to resolve their issues. It has been all done with little to no lawyer involvement.

Arrears

On the second pay period of October 2022, arrears will be deducted. These deductions will include any missed payments in the last year that may be due to sickness, IOD, area 605 or any other means of missing payment owed to Local 241.

If you have been off for an extended period of time, it is possible that you may be in the arrears on your union dues. Arrears notices have been posted, letting you know when we will begin the collection of arrears. Please check the Union Board at your location.



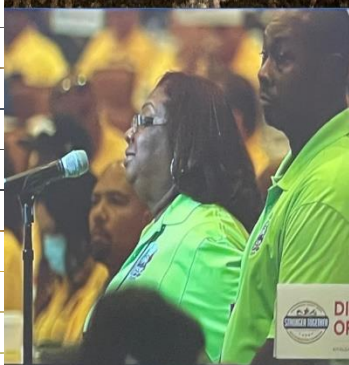

Members, please stay in your seats as much as possible and as long as possible that you can for your own safety. We are having members getting off of the bus confronting passengers and people in their cars. If you have to call control, just make sure that your bus is safely secure and stay on the bus.

FMLA

RESOLUTION A

ACKNOWLEDGING THE SACRIFICES OF FRONTLINE TRANSIT WORKERS DURING THE COVID-19 ERA

WHEREAS, the coronavirus epidemic showed the world the true meaning of “essential” employees – the brave workers whom people relied upon to survive when everything around us shut down; and

WHEREAS, since the pandemic began, transit and school bus workers have put their own lives on the line, bravely reporting to work every day, transporting riders in our communities to work, school, medical appointments, the grocery store and other important locations, and maintaining, repairing and sanitizing vehicles; and

WHEREAS, thanks to transit workers, health care workers were able to care for the sick in hospitals and clinics, grocery store workers were able to keep the shelves stocked so we could all eat, and other essential workers were able to report to work to perform their important jobs; and

WHEREAS, during the pandemic, we learned that driving buses with bad air circulation without the necessary personal protective equipment (PPE) is one of the most hazardous jobs; and

WHEREAS, each time a passenger coughed just a few feet behind a bus driver, operators’ hands gripped their steering wheels a bit tighter, as they knew they were in a potential death trap; and

WHEREAS, as if navigating a massive vehicle through heavy traffic and all sorts of weather conditions while enforcing rules and regulations was not dangerous enough, as we continued to urge transit agencies to protect our members on the job, unruly passengers who refused to comply with mask mandates required us to add compliance officers to our job duties; and

WHEREAS, in addition to their normal duties, school bus workers made sure that children were seated far enough apart to avoid the spread of COVID-19, constantly sanitizing the vehicles; and

WHEREAS, among the millions of front-line workers who faced a higher risk of getting sick or passing COVID-19 on to their families by going into work, many still did and do not make a living wage or have adequate health insurance; and

WHEREAS, thousands of transit workers and school bus employees have been infected with coronavirus, and hundreds of our members have paid the ultimate price; and

WHEREAS, during the crisis, ATU members were praised as “heroes,” but at the bargaining table, they have often been treated like “zeroes;”

THEREFORE, BE IT RESOLVED, that ATU mourns for each of the more than 200 members who tragically died due to COVID-19; and

RESOLUTION B

PROTECTING WORKERS' JOBS AND SAFETY IN TRANSITION TO CLEAN TRANSIT

WHEREAS, many states and provinces, responding to climate change, are now requiring that transit systems transition to zero emission buses, some with very aggressive timelines; and

WHEREAS, while this is a laudable goal, it will require a massive undertaking to provide the training necessary to thousands of transit workers who will be responsible for operating and providing preventive maintenance and repair on these cutting-edge vehicles; and

WHEREAS, performing this work safely must be an industry priority; and

WHEREAS, a recent ATU poll found that a whopping 83% of local transit union leaders do not feel that our operations and maintenance members are adequately trained to operate and work on zero-emission buses; and

WHEREAS, preventive maintenance on a transit bus nowadays is substantially different than it was just a few years ago, when skilled mechanics could likely have made do with the contents of their toolboxes; and

WHEREAS, advances in computer technology have fundamentally changed the nature of the job; and

WHEREAS, not one transit worker should be injured because they were operating or working on an electric vehicle without proper training or equipment; and

WHEREAS, the provision of training on the operation and maintenance of zero emission buses is critical to ensure that ATU members' jobs are not contracted out; and

* **WHEREAS**, in 2021, as a result of funding secured by the ATU in the U.S., the Federal Transit Administration (FTA) established the first ever National Transit Workforce Center for frontline transit employees; and

WHEREAS, the National Transit Workforce Center will conduct technical assistance activities for transit agencies with a strong focus on frontline transit worker skill development, serving as a hub to help transit agencies recruit, hire, train, and retain the diverse workforce needed now and in the future; and

* **WHEREAS**, the National Transit Workforce Center is headquartered at the International Transportation Learning Center, which is chaired by ATU International President John A. Costa; and

RESOLUTION C

**ATU APPROACH TO AUTONOMOUS VEHICLES DEPLOYMENT, SAFETY
AND TRAINING**

WHEREAS, the ATU recognizes that the serious and unresolved safety issues involving the eventual deployment of autonomous vehicles requires constant monitoring and evaluation; and

WHEREAS, information is essential to combat the safety, workforce and ethical impact of the deployment of autonomous vehicle (AV) technology; and

WHEREAS, AV technology is still incapable of operating safely in a variety of common scenarios and weather conditions, such as fog, snow, rain, and intersections with complex traffic signals; and

WHEREAS, in 2021, the City of Toronto suspended its trial of a self-driving bus after a similar bus crashed into a tree in nearby suburbs, critically injuring the onboard attendant; and

WHEREAS, just months before, Toyota announced an immediate halt to its all-electric autonomous bus that had been ferrying athletes and staff around the Olympic Village in Japan after it collided with a visually-impaired athlete attempting to cross the road at a crosswalk; and

WHEREAS, in 2020, the U.S. Federal Government's highway safety agency ordered an autonomous shuttle company to stop carrying passengers in 17 cities after a mysterious braking problem occurred in Columbus, Ohio; and

WHEREAS, our federal governments have failed to adopt comprehensive safety laws and regulations governing testing, certification, and operation of autonomous vehicles; and

WHEREAS, throughout our history, the ATU has successfully responded and grown in the face of technological changes through collective bargaining, organizing, and, in the U.S., the application of its Section 13(c) rights and protections; and

WHEREAS, many states and provinces have passed laws authorizing the testing and limited operation of autonomous vehicles on public roadways while also enacting laws prohibiting local jurisdictions and transit agencies from implementing safety regulations for the operation of autonomous vehicles at the local level; and

WHEREAS, the U.S. Department of Transportation, the U.S. Federal Transit Administration, Transport Canada think tanks, universities, independent researchers, and other entities have commissioned research and studies on the development and implementation of autonomous vehicles; and

WHEREAS, according to a new report from a transportation research institute at Carnegie Mellon University, skilled human transit workers are needed to supervise, manage, and maintain vehicles and ensure safety with any AV technology adopted for public transportation;

RESOLUTION D

STRENGTHENING NORTH AMERICA'S TRANSIT SYSTEMS

WHEREAS, ~~public transit~~ ridership has been down sharply over the past few years, even before the coronavirus pandemic; and

WHEREAS, the growth of work from home, the expansion of transportation network companies (TNCs) and falling bus ridership, especially among riders-by-choice, undermines the influence and support necessary for already underfunded public transit services, which further harms underutilized routes, resulting in a lack of transportation options for transit dependent riders; and

WHEREAS, North American transit systems have a backlog of repairs and improvements that run into billions of dollars; and

WHEREAS, the federal surface transportation bill in the U.S. known as the *Infrastructure Investment and Jobs Act* (IIJA) stands as one of the ATU's greatest legislative victories in the Union's history; and

WHEREAS, the IIJA, if fully funded, will boost transit spending in the U.S. by 63% by 2025; and

WHEREAS, transit worker labor protections provided under Section 13(c) of the Federal Transit Act, which have protected the job rights and collective bargaining rights of transit workers since 1964, were reauthorized in the legislation; and

WHEREAS, language included in the bill requiring labor-management safety committees with equal numbers of representatives from both sides will give transit workers leverage to make long overdue safety improvements to transit infrastructure; and

WHEREAS, the bill requires resources to be set aside for workforce development so that frontline transit workers will get the training they need to work on new zero emission buses; and

WHEREAS, while Canada has woefully underfunded public transit, the federal government has finally taken some encouraging actions in response to the pandemic which could lead to much needed transit investment;

THEREFORE, BE IT RESOLVED, that the ATU shall lead coalitions including unions, transit rider groups and others to ensure that annual appropriations legislation in the U.S. Congress fully funds the IIJA; and

FURTHER, BE IT RESOLVED, that the ATU shall continue to push the Canadian federal government to invest heavily in public transit; and

FURTHER, BE IT RESOLVED, that the ATU shall lead efforts to boost transit capital and operating funding in states and provinces all across the U.S. and Canada.

RESOLUTION E

EXPANDING TRANSIT TO REDUCE CARBON EMISSIONS

WHEREAS, climate change is an existential threat to the survival of our planet; and

WHEREAS, the polar ice caps are melting, and average annual temperatures are rapidly rising; and

WHEREAS, if we do not reverse the damage that human beings have recklessly done to the Earth's atmosphere within the next few years, life as we know it will be in jeopardy; and

 **WHEREAS**, the transportation sector generates the largest share (29%) of greenhouse gas emissions; and

 **WHEREAS**, while U.S. bus transit, which has about a quarter of its seats occupied on average, emits an estimated 33% lower greenhouse gas emissions per passenger mile than the average U.S. single occupancy vehicle, we can and must do better to meet the challenge of climate change; and

WHEREAS, one Canadian's decision to make a 32-kilometre commute by public transit instead of by car can cut carbon emissions by 9.1 kilograms per day; and

WHEREAS, if we also switch from traditional diesel-run transit buses to electric buses, we can save an additional 150 tons of greenhouse gases per bus per year; and

WHEREAS, many cities, states, and provinces have set targets of reaching "zero carbon" by 2050 at the latest; and

WHEREAS, it is widely recognized that modern public transportation systems are vitally important to reduce car dependence and greenhouse gas emissions, and to improve air quality; and

WHEREAS, transit jobs are "green" jobs; and

WHEREAS, transit workers are on the front line of the climate crisis and will play a critical role in saving our planet; and

WHEREAS, it is critical to provide training to transit maintenance and operations employees on new low emission vehicles so that we can make a successful transition from diesel buses;

THEREFORE, BE IT RESOLVED that the ATU shall actively promote public transportation as a means of reducing emissions from transport, lobby for workforce training to ensure a successful transition to zero emission buses, and support candidates who understand the need to address climate change in ways that create green jobs.

WHEREAS, even in areas where wages are in line with the cost of living, health care costs cause our members to make very painful choices which have a real impact on their families' lives; and

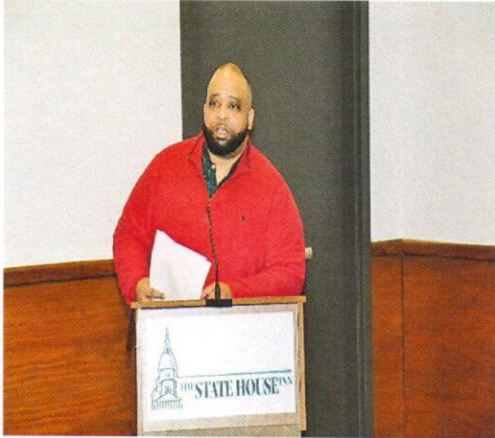
WHEREAS, some transit workers are forced to report to work when they are ill, driving and maintaining massive vehicles while taking responsibility for passengers' lives; and

Pension and RHCT

As of September 29, 2022, the Pension Plan funding is \$1,857,904,136.85 the Multiplier Factor remains at .0215, the economy is stable, so far while this administration has been in office the Pension Ratio nor the employee contribution has not increased, the Pension Plan has reached over \$2Billion dollars during the pandemic, now facing a pandemic and a possible recession your pension funding remains strong with the proper leadership and investments , while the Dow Jones and the S&P 500 is index is down 16% year to date our investment performance is strong such as Infrastructure, Bank Loan, Private Equity, and Real Estate giving the plan a return on investment of 12%.

As of September 29, 2022, the RHCT Plan funding is \$1.2 BILLION, this plan is well overfunded with the contribution at 1%, while this plan is 158% funded there is no reason the member has to suffer and contributing extra money to an over funded plan, so remember President Keith Hill along with his Administration took this fight to Springfield and change Legislation in order to bring the membership 2% of funding back on their paychecks. People has short memory on a successful battle.

First Transit Bid Pick

I reported last month that First Transit will be conducting the Pick in September and it will go into effect the in September. The Pick was conducted on September 29 2022, and the confirmation will be October 11, 2022, and the pick will go into effect the week of October 16, 2022.

Bus Maintenance Training Program

On September 27, 2022, Local Union 241 and CTA had a meeting for the Labor Management Committee via Teams, we all agreed that a Face-to-Face meeting is required, my anticipation is to have the classes and the training up and running by March 2023, December 31, 2023 is when this current contract ends and Local Union 241 goes back into negotiation in 2023 with a healthy training program under our belt with a health State and Federal Training Budget as well.

Pace West Ratified Contract

August 26, 2022, the members at Pace West voted to accept the Tentative Agreement, this Agreement has no give backs to the company. What makes this contract good is when you add a holiday that was an unrecognizable heritage and what America now is trying to erase out of our history books, Jubilee Day, Emancipation Day, Freedom Day, and Black Independence Day, Juneteenth was added as a Floating Holiday. With close to a 3% average per year, with an increase in the pension multiplier and a back pay plus bonus, and (3) three paid sick / elective days per year was added.

Pace Northshore Contract Negotiation

Local Union 241 and Pace Northshore negotiation was held September 30, 2022, we have several more meetings dates scheduled in the month of October, during which we will be deeply engaged with the membership. As President Hill expressed, we have Nothing to Give.

WORKERS' RIGHTS AMENDMENT

Illinois has a chance to make history and protect collective bargaining rights in the November 2022 elections, the Illinois General Assembly voted to put the Workers' Right Amendment on the ballot this year for voter approval, this amendment protects organizing and collective bargaining rights and stop politicians from intervening in the agreements reached by union workers and their employers. As the commercial you see on Television the worker states that because he does not have a college degree it should not stop him from making a good wage in his trade.

Unions working together with the AFL-CIO, (American Federation of Labor and Congress of Industrial Organizations) is working hard to make sure workers' rights and collective bargaining is protected. Collectively Bargain grows jobs and deliver economic growth most effectively, strong economics are built from the middle out, not the top down. Building a stronger, more vibrant middle class will provide all workers with a more direct path to economic opportunities. Passage of the Workers' Rights Amendments will protect Illinois workers from political attacks, and it will benefit working families, business, and the state economy.

PACE (West) (Southwest) (Northshore)
