*Below is my report for the month of September 2022, presented to the Executive Board on October 28, 2022 and the Members on November 1, 2022 during the Mass Membership Meeting.*

### NAACP

- Local 241 was honored to represent the Local and the NAACP for a discussion about the upcoming election. The topics ranged from voter suppression, workers' rights and how important judges are in today's election.
- Workers' Rights was one of the topics we voiced, the importance of this constitutional change and how it will help unions and others who would like to form a union. Voter suppression was another hot topic and it is alive and well in the United States.
- The last topic was about judges, I understand the importance but I also know the oppression they have put on minorities with unfair or just wrong sentences. But with the supreme court attacking woman's right and the possibility of other rights, it is important in this election.
- Also, twice this month, the Local had a voice on a weekly radio show **WCPT 820 am**, on both shows I had the opportunity to express our concerns for safety and how every day and every route we are dealing with problems. I explained how the new laws in place are a great start, but the major problem is enforcement.
- Not only in Chicago, this problem is happening all over the United States. But in Chicago we have a serious problem outside of the lack of enforcement, when a person is caught bringing them to a felony charge is often never done or banning them for the system is hard. All which makes our job harder and unsafe.
- The next show I had the opportunity to express how we are trying to get several bills passed in Springfield that will help us. One, our own police force, bringing back the CTA police force, mainly because the city is tied up with everything that is going on in the city, but most importantly, I strongly believe we can secure ourselves better.
- Also, I discussed how certain laws in Springfield like banning a person off the riding system, mandatory jail time and the homeless that ride the system, along with a few others. All and all it was a great opportunity to keep our safety in the forefront.

**SAFETY:**

- Local 241 has a standing monthly meeting with CTA and 308 to address our safety needs. Outside of that meeting we keep our meetings about safety alone to make sure our needs are addressed. This meeting has been taking place since late 2017.
- In this month's meeting we were able to get CTA to obtain armed security guards to assist with the police at turnarounds, relief points and some trouble spots along routes. Most of the locations are from the members during our rap session with CTA and CPD, so please keep informing the Union and lookout for the rap session at your location.
- We also addressed Halloween hotspots and that we see a presence there. Please see chart for locations

**EXPEDITED AND PRE-ARBITRATION & LABOR CHARGES:**

- In the month of October, Local 241 held "*Expedited Arbitration*" addressing over 250 grievances and winning 165 cases in some form by way of arbitration.
- This administration will keep addressing the grievances and keep working to reduce the amount of time members must wait on receiving a final decision.
- Pre-Arb was held in October, addressing 24 cases: winning 16 cases. So, let's welcome our Brother's and Sister's back to work.
- Labor Charges in the month of October: We had 3 new cases.
- We also had (2) letters of complaints/charges written to the International against the Local: (2) were responded to and all complaints/charges were dismissed and closed as unfounded.

**PENSIONEERS:**

- Local 241 has had over 6 sessions with Pace Northshore at the contract table, with a few more scheduled in the month of November. We have a Tentative Agreement on 21 of the 43 open items at the table. We are working hard to bring Pace Northshore the best contract under Local 241. ***We have nothing to give and nothing to lose!***
  - ✓ We are pleased to announce that as of 10/28/2022 we have reached a tentative agreement for our Brothers and Sisters of Pace Northshore. This will be our 10<sup>th</sup> contract with no losses or givebacks.

**JOB FAIR:**

- On October 1, 2022 Local to 241 and the Chicago Transit Authority held its third job fair.
- This job fair had over 500 people scheduled to attend, which is a good number for the second in person job fair.
- Local 241 has Partnered with the CTA to assist in helping with the hiring, we see it as a way to help and give us an opportunity to get our family and friends hired.
- We will be holding another job fair in the upcoming months, hopefully. So please be on the lookout and let's help get our friends and family a job with us to earn a great living.
- I would like to thank the Officers, Executive Board Members and Stewards who represented Local 241 at this fair and everyone who helped put the word out about the fair. **Remember all jobs are now full-time positions!!**



All bills are paid or current. Local 241's 6-month audit is still underway. As always, I will keep the membership informed of the results as soon as they are available.


## Grievances

## ***Assistant Business Agent Maintenance Report November 2022***

### **Overtime**

As the Maintenance Department has worked with the Chicago Transit Authority from the Pandemic to lack of employment hiring, it is time now to take a stance, as myself and all the Maintenance Union Reps and Stewards have told the Membership that the System Pick is on hold because we are 70 Mechanic position short we been working tons of overtime in order to keep the system afloat, while Management is still disrespecting our membership, and the pay situation has not been answered, it's now time to take action.

The Maintenance Leadership of Local Union 241 is asking our members starting November 14, 2022 not to do any overtime until Management decides to come to the table and address our concerns. We are asking our members not to do any shift changes to cover shifts, Local Union 241 wants to regain all of our work that the shops are doing but when you're not paying us competitive wages and now want to give us the work the Authority deem to be "Shop Work", we will be filing a grievance on all pro-heat rebuilt that we are doing and we will team up with Union 701 to ensure that the grievance process will go through if not on our end then on their end. Also, we will be asking Local 701 members to stop doing overtime as well, the members over at 701 knows Local Union 241 struggles as the weeks to come, this fight may get ugly, but this is just the beginning.

As many Maintenances Mechanic, Instructors, and Servicers have heard from Donald Bonds mouth "THIS WAS NOT ASKED FOR BY YOUR UNION ", well we about to do more than ask, I'm hearing this phase from the Instructors, Servicers to the Mechanic, what was asked and presented in contract negotiations, we started with for all Prevailing Wages, and for the Instructions department was 10% higher wages then the union they train. During Contract Negotiations I told CTA that we are losing Mechanics at an alarming rate, and all that was said is that 241 needs a Training Program and how the work we were preforming was not up to standard.

Now with the lack of hiring, retirements and every place is hiring over \$10 dollars more than what we are getting paid the retention of Mechanics is scares, when you are hired into the CTA you have to go through (5) five months of training and at the end of the training you receive HVAC certification and a CDL, we have lost good mechanics, the mechanics we lost to the Public Workforce and to Local Union 701 all said if they were making at least \$45 dollars an hour they would have stayed and

now they all are making over \$52. We are not faced with a Company that will not acknowledge our skill, a Company that will not acknowledge that the CDL we have, holds weight, the former employees' thanks CTA for the added skill, and the CDL that they accrued while getting paid from the Authority.

This part is background information for all the idiots who's saying that canceling a pick shows poor leadership, we all know that if we have (70) seventy open position that CTA in the past have eliminated our jobs this is not the first pick that the Maintenance Department Canceled due to high open positions, Back in 2004 – 2005 we done this to preserve our jobs from the 2010 lay-off, back in 2013 while the Mechanics held off on the Pick CTA went forward with the Servicer Pick and eliminating every other weekend from all servicers, we held weeks of protests and we fought but we got them weekends back, and from that point on, we pick together or we don't Pick at all, back in 2016 the Easter pick was held off because we were (40) forty mechanic short, and we hired 10 mechanic and went through with pick in the fall, In 2020 we lost 10 mechanic spots due to essive red-lining.

During contract negotiations I was told by a former 241 member that we were going to lose maintenance positions, when I ask Donald Bonds at the negotiation table, I was told that we were not going to lose any positions, but we did. This time we will not let budget take our spots that easy so it can go to more managers and more operational employees, while our instruction department needs more instructors. So, the Idiots who calls it poor leadership is the ones who's not fighting with us to ensure that our workforce stays intact, who's not fighting with us to make sure we have compatible wages, these are the ones that's good because they are Number 1 in pay. These are the ones that want our Maintenance Jobs to be redirected to General Office and Operation Supervisors and Instructors.

To fight a good fight, we must stay focus on the mission with several assignments, First stop being disrespected, if management wants respect they must give respect, grow a backbone and stand up, call your Union Reps, or call Marqueal Williams 312-888-6364. Second STOP DOING THE OVERTIME, yes, THE UNION NEEDS YOU TO WORK THE OVERTIME ONLY ON Thanksgiving, Christmas, and New Year's, this is not to bail CTA out this is because we (THE UNION) stopped the pick, and this is what the UNION needs for the days could be covered. Third we must make every attempt to be heard, if you want to show solidarity with the Maintenance Department on November 14<sup>th</sup> and 15<sup>th</sup>, we are asking that "no one work overtime", from General Office to Bus Operators to Local Union 701 and every Local Union within the CTA, I will forward them the invite, a small step for a giant leap.

Last, I will use our pollical platform to accomplish our goal, I am currently the President of the Illinois Joint Conference Board and Tim Westhoff is the Vice President of the IJCB, in next month report I will come up with our political agenda, we must first achieve our NO OVERTIME goal as a start and build from there.

- I will be filing a Class-Action Grievance on the Pro-Heat Rebuilt, if you are doing a rebuilt, please contact your Union Rep at your location.
- If any Buses are going to another location to be repaired, please contact your Union Rep at your location to file a grievance.

## **Pension and RHCT**

As of October 27, 2022, the Pension Plan funding is \$1,814,181,718.38 the Multiplier Factor remains at .0215, the economy is stable, so far while this administration has been in office the Pension Ratio, nor the employee contribution has not increased.

## **First Transit**

First Transit will be increasing the starting pay, from \$17.00 to \$20.00, the three-dollar increase will be current for everyone up to (5) five years, Local Union 241 decreased the progression at First Transit from 10 years to an 8-year progression. Everyone after year (5) five will receive a pay increase but not substantial as year 1-5.

## **Bus Maintenance Training Program**

On October 28, 2022, Local Union 241 and CTA had a meeting for the Labor Management Committee Face-to-Face meeting, this is our third meeting, and we are meeting weekly, my anticipation is to have the classes and the training up and running by March 2023.

3. Check for parts order before ordering parts to make sure duplicates parts haven't been ordered.
4. Tardy/Attendance when you are at the toolbox meeting you must be dressed for work.
5. Out of Work Area: If you are going out for lunch you MUST let Management know that you are going out for lunch.
6. Electronic Device Policy: if you are on your cell phone you should be on break.
7. WEARING YOUR FACE MASK; the face mask is an option and not mandatory.
