

# Below is my report for the month of November and December 2022, presented to the Executive Board on December 30, 2022 and the Members on January 3, 2022 during the Mass Membership Meeting.

On Tuesday December 6, 2022 an election of Officers, Executive Board Members and Stewards took place, I would like to take this time to thank everyone who participated in the democratic process by either being a candidate for office or by voting. I would like to personally **THANK YOU** for re-electing me your President/Business Agent, **WE ARE ONE!!** 

There are many issues that we must work on together including but not limited to, working on safety issues, working to refine the runs, working with our state legislators by traveling to Springfield for legislative issues and bills, organizing and continue to offer training on issues that affect this membership, **WE ARE ONE!!** 

We must make a serious commitment to our members working in the maintenance department, we must fight harder at inclusion and make everyone notice the hard work that is done by our members. Remember, the safety of the drivers' jobs begins in the maintenance department, **WE ARE ONE!!** 

#### **SAFETY:**

- Local 241 has a standing monthly meeting with CTA and 308 to address our safety needs. Outside of that meeting we keep our meetings about safety alone to make sure our needs are addressed. These meetings have been taking place since late 2017.
- In upcoming months, we will restart our meetings with the CTA and CPD to address our concerns and keep our problems in the forefront. We'll keep the pressure on CTA for armed security guards to assist with the police at turnarounds, relief points and some trouble spots along routes.
- ➤ We also will be asking CTA for brighter lighting in our parking areas, less public access on our lots, secured remote gate but that will be enclosed gates at all locations.
- ➤ The #4 Cottage Grove relief point will be at 95<sup>th</sup> and the Redline.
- Please report all bathrooms that may be unsafe like the door latch is broke, bad lighting, or where the public have access to, in terminals.
- Also, Local 241 and PACE Safety Committee met twice in December. This committee represent all of 241 locations as well as all of PACE. Myself and Brother Caesarie Montgomery represented the union. We will be reaching out to all ATU locals as well as the non ATU locals to gather their input about safety and meeting with them on a regular basis.

#### **EXPEDITED, PRE-ARBITRATION, STEP II & LABOR CHARGES:**

- In the Month of November and December Local 241 did not hold expedited arbitration, Local 241 will be addressing over 300 grievances in the month of January.
- This administration will keep addressing the grievances and keep working to reduce
  - o the amount of time members must wait on receiving a final decision.
- Pre-Arb was held in November but not December. In the Month of November, seventeen (17) Brothers and Sisters were returned to work.
- I attended Step II grievance meeting: presenting fifty-three (53) cases and winning twenty-one (21) cases.
- Labor charges in the month of November and December: we had one (1) new case. The Local also had four (4) cases dismissed. And no new cases filed against the local.
- We also had two (2) letters of complaints/charges written to the International Union against the local. Two (2) were responded to and all complaints/charges were dismissed and closed
- > as unfounded.

#### **JOB FAIR:**

- On December 2, 2022, Local 241 and the Chicago Transit Authority held its fourth job fair.
- This job fair had over 500 people scheduled to attend, which is a good number for the third in person job fair.
- Local 241 has partnered with the CTA to assist in helping with the hiring. We see it as a way to help and give us an opportunity to get our family and friends hired.
- We will be holding another job fair in the upcoming months, hopefully, so please be on the lookout and let's help get our friends and family a job with us to earn a great living.
- I would like to thank the officers, board members and stewards who represented Local 241 at this fair and everyone who heled put the word out about the fair, remember all jobs are now fulltime positions!!

#### **MOTIVATEME PROGRAM:**

- ➤ Beginning January 1<sup>st</sup>, log on to MyCigna.com or the MyCigna mobile app, create a log in or sign in. Register and complete a Health Care Assessment through the app. This is a required first step to enroll in the program to be eligible to receive any credits.
- From there you must complete one preventive exam or screening and at least one CTA sponsored wellness activity, then select health programs and other activities that you want to participate in.
- ➤ To receive your full credit amount, activities are automatically recorded for you, except for the Live Well Work Well sponsored activities, which must be self-reported to receive credit. You will have until October 31, 2023, to participate and log your wellness activities.
- The voluntary **MotivateMe Program** and the health plan you select, will determine the amount of annual health care premiums not collected.
- The annual health care premiums savings will be up to \$270.40 for single coverage and up to \$520.00 for family. **REMEMBER THIS IS A VOLUNTARY PROGRAM!**

#### **SUMMARY OF RETENTION INCENTIVE PLAN:**

#### **RETENTION INCENTIVE BONUS:**

All current employees represented by Local 241 (with the exception of bus mechanics hired in 2022 and 2023 who will receive the bonus and change in progression set forth in paragraph 2 below) will receive the following retention incentive bonuses based upon hours worked:

- A. First Payroll period in February 2023 bonus: a one-time payment equal to 3% of the employee's gross earnings for the first 1250 hours worked (regular and overtime included) between 7/1/22 12/31/22. To be eligible an employee must be on the payroll on December 31, 2023.
- B. First Payroll period in August 2023 bonus: a one-time payment equal to 3% of the employee's gross earnings for the first 1250 hours worked (regular and overtime hours included) between 1/1/23 6/31/23. To be eligible employee must be on payroll on June 30, 2023.
- C. First Payroll period in February 2024 bonus: a one-time payment equal to 3% of the employee's gross earnings for the first 1250 hours worked (regular and overtime

#### **SUMMARY OF RETENTION INCENTIVE PLAN (Cont.):**

included) between 7/1/23 - 12/31/23. To be eligible an employee must be on the payroll on December 31, 2023.

(Note, for example: an operator at top rate who works 1040 hours during each of the six months periods the total bonus would receive in excess of \$3,500 and for a bus mechanics at top rate the bonus would be in excess of \$3,750. For an operator who worked 1250 hours (210 overtime hours) during each of the periods, the total bonus would be in excess of \$4500 and a bus mechanic would receive in excess of \$4750).

#### **RETENTION BONUS AND RATE ADJUSTMENT FOR NEW BUS MECHANICS:**

- New bus mechanics hired on or after January 1, 2022 and up until 12/31/2023 will receive a payment of \$1,000, less applicable payroll taxes/withholdings (Subject to repayment if employment ends within 12 months of hire).
- Current bus mechanics hired after 1/1/2022 will receive payment of the bonus within 45 days after execution of the agreement by the Union and CTA.
- All mechanics on the progression shall have their wage rated adjusted to 100% of the top rate, and through **12/31/2024**, the wage progression for mechanics shall be adjusted by raising the starting rate to the top rate.

#### **WAGE PROGRESSION FOR OPERATORS:**

Through 12/31/2024, the wage progression for bus operators shall be adjusted, and all current operators on the progression shall have their wage rate adjusted accordingly;

#### Hire Rate -

- 75% of top rate (Rate would be \$28.43 based upon current top rate)
- After 24 months 80% of top rate (Rate would be \$30.32 based upon current top rate)
- After 33 months Top rate

#### RETENTION BONUS AND RATE ADJUSTMENT FOR NEW BUS MECHANICS (Cont.):

#### **MINIMUM RUN GUARANTEE:**

Through 12/31/2023, all runs operated by full-time bus operators only will pay a minimum of 8 hours.

#### **NEW HIRES:**

New hires from outside CTA will receive a \$1000 incentive bonus, less applicable taxes/withholdings, but subject to repayment, if employment ends within 12 months of hire, The bonus will be paid on first paycheck.



#### **AVAS-BLIS Revised Order Summary**

- Bus Operators must sign and complete the "Operator's AVAS Dispute Form" and turn in to the Transportation Manager no later than four (4) days after the third (3<sup>rd</sup>) and final posting for the relevant bi-monthly period.
- Failure to submit the "Operator's AVAS Dispute Form" within the four (4) day period shall be taken as the bus operator's agreement of the AVASBLIS data that is posted.
- Local 241 may grieve the level of progressive discipline.
- Local 241 must be provided all information that the CTA relied on for disciplinary action including AVAS-BLIS data and reports and any other relevant CTA and Bus Operator reports.
- CTA will notify the Recording Secretary of Local 241 of the disciplinary action by email.
- Local 241 shall email the CTA a completed AVAS-BLIS Grievance form within fourteen (14) days if they want to meet with CTA about the disciplinary action.
- The CTA Vice-President of Bus Operations or his designee will meet with Local 241 Recording Secretary or his designee at least once a month about the disciplinary action. If they are unable to agree on the discipline, Local 241 has the right to protest the discipline through the expedited arbitration procedure within twenty-one (21) days of this meeting.
- If Local 241 does not email the CTA about the disciplinary action, the discipline shall be deemed conclusively for just cause.

#### **Assistant Business Agent - Maintenance Report**

#### HAPPY NEW YEAR!!



#### Marqueal L. Williams

My name is Marqueal L. Williams I am the Assistant Business Agent for ATU Local 241. My job is to oversee all CTA & Pace Maintenance and First Transit Paratransit Operators. I am also the President of the ATU Illinois Joint Conference Board.

#### **HAPPY NEW YEAR**

The New Year calls for remembrance of all that was accomplished in 2022 and sets an agenda for the 2023 year. In January of 2022 the UNION brought the CTA Maintenance worker a contract, pay increase and a 5% bonus with a max of 4,000 hours worked during the 2020 pandemic.

First time in the History of Local Union 241 Maintenance Department, I moved the wage percentage from 103% of a Bus Operator rate of pay to 106%. We moved the clothing allowance from \$165 to \$197.50 plus your \$50 dollar shoe allowance. Your Local Union Leadership added Vision Benefits, Flex Account, Lay-Off Protection from 2010 to 2013, and added a repayment plan for 120 months (10 years) for Retirement Plan Participants who were discharged and brought back through arbitration, and don't forget about the Motivate Me. If you do not want your insurance rates to increase in 2023 just participate in the Motivate Me on your Cigna app. We gave you a Contract with Nothing Lost or Given Back!!!

CTA Members we brought you 2% back into your pockets by lowering the RHCT to 1%, and I brought CTA Maintenance Department an Accredited Training Program with a budget of \$15 Thousand per-participant from the State of Illinois this is money we already have.

Next I started Pace West Contract
Negotiation in May of 2022 and we
brought Pace West Maintenance workers
a contract in August of 2022 with a \$4.08
raise over the life of the contract.
Eliminating the Wage Progression for Bus
Servicers, and increasing the tool
allowance to \$425 dollars. The Union

negotiated Sick Elective Days into the contract.

I added a provision in the contract for all Maintenance employees have the option of picking a red-lined position, we increased the Short Term Disability Allowance, and added Expedited Arbitration in their contract, now they can take accidents grievances to Expedited and not to the National Safety Council. Also during a Pandemic and Pre-Recession we moved the Pension Multiplier from 1.85 to 1.875. Over all years of service. (not like CTA, only the best 4 out of 10 years). And I brought Pace West an Accredited Maintenance Training Program as well. With a wellness bonus of \$1,000 dollars.

NEXT I started Pace North-Shore Contract
Negotiations in August of 2022 the Union
brought the Pace North Shore
Maintenance workers a \$5.79 increase
with a retro of \$1dollar/hour from January
1, 2022 to October of 2022. We Increase
the life insurance from \$10,000 dollars to
equal the employee's one year's wages at
top rate. We added the right to challenge
accidents in regular arbitration. I added a
Tool Room List that Pace is required to
stock. The Tool allowance was increased
to match Pace West at \$425 dollars. We
also raised the 401(k) Retirement to 4.5%

during a Pandemic / Pre- Recession. And I brought Pace North Shore an Accredited Maintenance Training Program as well. With a bonus check of \$1,000 dollars.

Local Union 241 fought to give EVERYONE including Bus Servicers and Bus Servicer Apprentices a 3% work incentive pay every six months till January 2024.

I stopped the pay progression for Mechanics, and we gave every new employee a \$1,000 dollar bonus.

Being President of the Illinois Joint
Conference Board our main agenda was
the passage of the Worker's Rights Bill in
Illinois. Myself and my Vice president Tim
Westhoff held several meetings along with
all other ATU Legislative Board to get this
accomplished.

Plus I got back this year 11 members who were terminated.





#### <u>Agenda</u>

First I would like to Thank everyone who supported me for the Third Vice President/Assistant Business Agent Maintenance position, the votes were counted on December 22, 2022. For the next two months I have an agenda for the Maintenance Department.

The agenda is to get back into talks with the CTA about the 3% increase, during the runoff election it was made clear that we would resume talks after the Holidays. Myself along with President Keith Hill will make this our top priority for the meetings to resume. Also we are asking for the Bus Servicers to lower the starting progression from (3) three years (9) nine months to (2) two years, this is what we did for the Mechanic during the 2018 contract Negotiations and now we have no progression for all Mechanic. For Pace North Shore and Pace West I stopped the progression completely in the Maintenance Department for Bus Mechanic and Bus Servicers, and I plan to do the same for Pace Southwest.

We are currently in talks with CTA about having retired Bus Mechanic to work part time, the concept is they would work 32 hours Friday, Saturday, Sunday and Mondays only, this would free up the weekends for current members who wants to use a VRD and when it goes into effect we can add more Weekends, Monday & Fridays on the actual pick. Also on the Agenda is to start back the Maintenance Training Program in order to get this up and running by June or July of 2023.

The Agenda also consists of the Maintenance Pick, we may need a System Pick in order to rebalance the System, we stopped the Pick because we were 74 position open in the Maintenance Department, after hearing your concerns we definitely going to have a Pick, the members made it clear no matter if we lose positions you want a pick. The Union will fight to maintain every pick position that we can but we all know what happens when we go through with a pick with excessive spots being open, CTA take the position and reallocate the position in General Office, Transportation or Management.

#### **Bus Servicer Apprentice**

Currently I have an overtime

Memorandum of Understanding (MOU)
that is being discussed with 241 legal
team and CTA legal team to bring you
overtime. We all knows that Bus Servicer

Apprentices (BSA) only make a little over \$15 dollars, while Bus Mechanic and Bus Servicers are working tons of overtime and hitting the \$90-\$100 thousand dollar mark while a BSA makes \$29,700.00 twenty-nine thousand seven hundred dollars yearly.

I will make a change in how the BSA gets hired for regular jobs. I will post on my Illinois Joint Conference Board page on jobs that are hiring in the state of Illinois, and use my platform to make a difference in their lives. I will work closely with Learning and Support to look at other Jobs that the BSA qualifies for other than Bus Servicer.

For my Bus Servicers I will start a Labor Management Bus Servicer Committee and have Bi-Monthly meetings at North Park to address all Bus Servicers issues, myself along with Larhon Brownlee will also have a Bus Servicer Apprentice Committee to see how we can cut down on discipline, discharges and unbalanced work assignments.

My Illinois Joint Conference Board conference will be held in Springfield Illinois on May 1-5, 2023 if you are on vacation during that week I urge you to call me and make arrangements to attend. You may ask why should I attend

the Illinois Joint Conference, this is an educational conference to teach you how legislation is transpiled through the Illinois General Assembly, Illinois House and Illinois Senate members, this give you the opportunity to meet your State Representative from the district you live in, and have your concerns addressed personally, also during our legislative breakfast you can personally meet the Governor of Illinois J.B. Pritzker, and Illinois House Speaker Chris Welch





At this conference you will learn other ATU Local Union contracts, have the opportunity to speak one on one with labor attorneys, spend time with International President John Costa and have Union Training Classes during this Conference.


